

S ince the new Cabinet came into office following the May 2012 elections we have undertaken a fundamental review of the council's budget so that it provides a sustainable budget plan, within predicted future funding levels and aligns with the key objectives of the administration as set out in the new Corporate Plan which covers the years 2014 to 2017.

We have therefore produced a budget which balances the need to provide essential services to the public against the funding pressures and requirement to make significant levels of savings over the next three years. A pragmatic approach has been made on the level of savings that can reasonably be expected to be implemented in 2013/14 and those cost



pressures which if not already identified as committed growth would still need to be met in order to maintain essential services. Such a position cannot be achieved without increased funding either from council tax, temporary increased support from use of reserves or a mix of both.

The Cabinet's key priorities in terms of individual services are those associated with Education and Schools; Social Services; those potentially affected by Welfare Reform changes (for example, homelessness, housing benefit and council tax reduction); waste and highways. Feedback from consultation with the Scrutiny Committees has also placed emphasis upon the level of proposed Social Services savings and the impact of Welfare Reform changes.

In arriving at the final revenue budget proposals, the views of the Schools Budget Forum have also been very carefully considered and the schools budget includes the protection set by the Welsh Government.

Even with the proposed increase, the Vale's band D council tax at £985.14 will still be below the average for Wales and the increase of £45.09 per year on a Band D property equates to less than £1 per week. I hope that everyone understands that we have no alternative to make this increase in council tax otherwise services would suffer to an unacceptable level.

How is your Council Tax calculated?

The total Council Tax for each community area in Band D is found by adding to the Town/Community Council levy the charges from:

Most dwellings are subject to Council Tax. There is one bill per dwelling, whether it is a house, bungalow, flat, maisonette, mobile home, or house boat, and whether it is owned or rented.

Each dwelling has been allocated to one of nine bands according to its open market capital value at I April 2003. The Band your dwelling is in will determine the Council Tax you pay as follows:

For Example:

The total Band D Council Tax for the Barry Town area is £1,216.22 This is found by adding the Town/Community Council levy (£49.80) to the charges for the Vale of Glamorgan (£985.14) and the South Wales Police and Crime Commissioner (£181.28).

The National Assembly for Wales sets a **Standard Spending Assessment (SSA)** for each Council. This figure is used to distribute Revenue Support Grant to Councils.

This year our SSA is £219,212,245 and our Net Budget is £217,746,454 (after adjusting for discretionary rate relief and Council Tax Support Grant). This represents a Band D equivalent for Council Tax of £985.14 after all grants etc.





Am I registered to vote?

If you pay Council Tax you are not automatically on the Electoral Register.

Electoral registration is a separate process performed by the elections office. Any person who is 18 years and over and is a British, Commonwealth, Irish Republic or European Union member state citizen can register. To register to vote, you need to complete an electoral registration form. Fill it in, sign it personally and return it to your local electoral registration office.

Are you entitled to Housing and/or Council Tax Reductions? Find out if you can cut your Council Tax and rent liability.

From April 2013 Council Tax Benefit will be replaced by a local Council Tax Reduction Scheme. Most of the rules are the same as Council Tax Benefits but there are some differences. There will be no need for those people already claiming Council Tax Benefit to apply for a Council Tax Reduction unless they have been notified their Council Tax Benefit has been stopped.

Are you on a low income (with savings of less than £16,000, unless you are on Guarantee Pension Credit), having difficulty paying some of your bills and using your capital to support your living standards? Council Tax Reduction could help pay towards your Council Tax bill and Housing Benefit could help towards your rent. The Council would like to assist our residents to apply for help - why not apply today? To find out if you qualify, we need to take into account your circumstances, including income, savings, age and how many people live with you.

Some examples follow (Housing Benefit does not cover utility or other amenity charges):

A single pensioner over 65 whose rent is £90 a week with Council Tax of £900 per year (£17.30 per week) and a weekly income of £163.50 per week. Council Tax Reduction could be about £900 (£17.30 per week) and Housing Benefit about £90 per week.

A couple with two children aged under 16, rent of £130 per week, Council Tax of £1,153 per year (£22.11 per week) and a total weekly household income of £295 per week. Council Tax Reduction could be £798.20 (£15.35 per week) and Housing Benefit about £108.03 per week.

Don't delay, apply today, as in most cases benefit can only be paid from the Monday following the receipt of a valid application form. If you claim Pension Credit, Income Support or Job Seekers' Allowance, you should have received a form to claim Housing Benefit and Council Tax Reduction in with your application.

Weekly kerbside recycling collections

Paper, glass, cans, cardboard, plastic, foil, juice cartons and drained aerosols can all be mixed together in your kerbside box and for collection weekly. Either put this in a free kerbside box or buy a blue co-mingled bag with a weighted base and Velcro secured lid for $\pounds I$ - The Alps Depot, Wenvoe and Civic Office, Barry stock both. Don't forget they also have $\pounds I$ elasticated nets available, which may be neatly tied and fit over your kerbside box.

Alternate week garden waste collection

Our popular alternate week kerbside collection for garden waste is available for even more weeks of the year during 2013 and 2014. Our 'ring & request' service runs from 2 December 2013 to 21 February 2014. Reusable bags cost £1 or disposable bags three for a £1, available from Council offices and all Vale libraries.

Weekly kitchen waste recycling

Food items such as: peelings, meat, bones, dairy products and leftovers can be disposed of weekly. Replacement corn-starch biodegradable bags can be obtained by tying a bag or a piece of cloth to the handle of your caddy to signal to our crew to leave you another roll on their round. Alternatively, call into your local library, or Alps reception to collect a roll.

Household Waste Recycling Centres

Atlantic Trading Estate, Barry (CF63 3RF) and Llandow (CF71 7PB) are open seven days a week – closing only for Christmas, Boxing and New Year's Day. Summer opening times operate from 31 March - 26 October 2013.
