Re: Police and Crime Commissioner Election –South Wales Police Area Thursday 2 May 2024

As the Police Area Returning Officer (PARO) for the South Wales police area, I am writing to provide key information and relevant dates for the Police and Crime Commissioner election (PCC) scheduled to take place on Thursday 2 May 2024.

Introduction

In Wales there are four police areas South Wales, Gwent, Dyfed Powys and North Wales. South Wales covers the administrative areas of seven unitary authorities - Bridgend, Cardiff, Neath Port Talbot, Swansea, Merthyr Tydfil, Rhondda Cynon Taf and the Vale of Glamorgan.

The Election process is governed by the terms of the Police Reform and Social Responsibility Act 2011 and other relevant legislation. I will be assisted in my duties by six Local Returning Officers (LROs) from the other local authorities who are also subject to national legislative requirements and guidance.

Police Area Returning Officer (PARO) role

As Police Area Returning Officer (PARO), I am responsible for the overall conduct of the PCC election for the South Wales police area, and for liaising with the LROs in the South Wales police area.

I am also responsible for giving notice of the election, the nomination procedure, encouraging participation, ensuring that the candidate election address requirements and the procedures for submitting those addresses are complied with, the collation of local totals and calculation of the result and finally the declaration of the result.

Local Returning Officer (LRO) role

Local Returning Officers (LROs) are responsible for ensuring the election is administered effectively in their voting area including the provision of polling stations, the printing of ballot papers, appointing polling station staff, the conduct of the poll, managing the postal vote process, the verification and count in their voting area and transmission of the local totals to the PARO.

Potential combined elections

In Wales, the 2024 PCC elections are scheduled to take place on Thursday 2 May.

However, there remains the potential for a UK Parliamentary general election to also be held on the same day at very short notice.

Due to the complexity this arrangement could involve and to try and minimise risk within the electoral process, the potential of combined elections has been factored into all my logistic election planning including the verification and timing of the PCC count processes.

Candidates and agents

Dedicated web pages will be available, providing information for candidates and agents, and will be updated in due course with links to the downloadable forms (including the nomination pack) and other PARO updates. Please visit:

On Monday 11 March 2024 at 3:30pm via Microsoft Teams a representative from the Electoral Commission, the office of the South Wales Police Commissioner, and I will be hosting a candidate and agent briefing session and providing an overview of the role of Police and Crime Commissioner.

The briefing session will provide vital information for potential candidates and their agents including the nomination procedure, polling information, the verification and count process, candidate spending and election expenses and finally the role and responsibilities of the Police and Crime Commissioner and arrangements for the declaration of acceptance of office for the elected candidate.

A further briefing session for candidates and agents will also be provided after the close of nominations on Thursday 18 April at 11:00am.

Polling Day

The poll will take place on **Thursday 2 May 2024 from 7am until 10pm.** Each LRO will be responsible for the conduct of the poll and polling stations in their voting area.

Ballot papers will be printed with a Unique Identifying Mark (UIM) individual to each LRO voting area along with an official mark set by the PARO.

The Ballot Paper colour for the South Wales police area will be **Pearl Grey**.

Verification and Count

The verification and count of the PCC Election will be conducted at local counting centres across the South Wales area with a regional hub based at the Princess Royal Theatre, Port Talbot, SA13 1PJ where I shall declare the final result of the election. The process to be followed requires local declarations of result in each authority area followed by a collated, overall result for South Wales.

All LROs in the South Wales Police Area will commence the verification on Friday, 3 May, 2024 if the PCC election take place as a stand-alone poll.

The count will commence after the conclusion of the verification process on Friday, 3 May, 2024, if the PCC election takes place as a stand-alone poll.

In the event that the poll is combined with a UK Parliamentary election, for both elections, the verification process will take place following the close of polls at 10pm on Thursday 2 May, with the count deferred until Sunday, 5 May, 2024.

Each LRO will be responsible for communicating the verification totals to myself, and at the close of the verification each LRO will also secure all ballot papers until the commencement of the count process.

Details of when each LRO will be starting their count will be made available on the PARO website – <u>www.npt.gov.uk/elections</u>

The count will be administered using the 'First Past the Post' voting system, as opposed to the Supplementary Vote system as used for previous Police and Crime Commissioner elections. This is due to a change in the law introduced by the UK Government via the Elections Act 2022.

As PARO I will provide updates at the regional hub venue via social media and direct to LROs throughout both the verification and count, although due to the size of the South Wales Police Area it remains difficult to estimate how long the count process will take and my emphasis will be on accuracy as opposed to speed. I trust the above information is of assistance and sets out the initial planning towards an effective and efficient PCC election in the South Wales Police Area.
