**Proposal to reconfigure primary provision in the Western Vale by;**

- **Creating a new 210 place primary school building with a 48 part time place nursery class for Llancafarn Primary School in Rhoose.**
- **Transferring staff and pupils from the existing Llancafarn Primary School building into the new school building.**
- **Changing the age range of Llancafarn Primary School from 4 – 11 years to 3 – 11 years**

In March 2018, the Council launched a new consultation aimed at taking a holistic view of primary school provision in the Western Vale. The aim of the consultation was to inform the community about the school re-organisation proposal being put forward to build a new 210 place school building for Llancafarn Primary School, with the addition of 48 part time nursery places which would be located in Rhoose, and to seek feedback on this proposal.

Members of the community raised a number of important concerns regarding the impact to their local areas, as well as raising additional questions about the proposal, while seeking to ensure their views were understood.

As a result of feedback, the Council has felt it is important to include greater detail in the consultation document and to provide stakeholders the opportunity to consider this in within a new consultation timeline.

I enclose a copy of the consultation document that describes our proposal and explains how you can respond. The consultation period runs from 21 May 2018 to 9 July 2018.
