Cabinet Quarterly Work Programme January to March 2019

Purpose of the Report

Reason for the Recommendations

2. In accordance with the provisions of the Local Government Act 2000 and the Council's Constitution, the Cabinet Annual Strategic Forward Work Programme sets out matters which the Executive and Full Council are likely to consider during the period up to end March 2019.


