• To reinstate the timetable of meetings from September 2020 to May 2021 and to set a new date of 14 September 2020 for the holding of the Council's Annual Meeting that was due to take place in May 2020.

#### Recommendations

- 1. That the timetable of meetings that had been suspended as a result of the COVID-19 pandemic continues from September 2020, subject to any future changes in arrangements for meetings deemed appropriate by the Mayor of the Council or the relevant Committee Chairman.
- 2. That in pursuance of recommendation 1, above, the Council's Annual Meeting be held on 14 September 2020

### **Reasons for Recommendations**

- **1.** To continue with the calendar of meetings for the 2020/21 municipal year from September 2020.
- 2. To allow the Council to hold its Annual Meeting, which was due to be held in May 2020.

### 1. Background

- **1.1** At the Cabinet meeting dated 23rd March, 2020, Cabinet considered a 'Coronavirus Preparations, Officer Delegations and Council Working / Business Continuity' report which dealt with temporary emergency Governance arrangements implemented to ensure business continuity within the Council as a result of the implications of COVID-19 pandemic.
- **1.2** As a result of the implications of COVID-19, the Leader and Chairmen of Council Committees on 16th March, 2020 agreed that all meetings of the Council except for Cabinet on 23rd March, 2020 be cancelled for the foreseeable future.
- **1.3** The timetable of meetings for the Municipal Year that was discussed at the Cabinet Meeting on the 20th January, 2020 was subsequently suspended.
- **1.4** Remote meetings of the Council to consider urgent items have taken place since the 23rd March, 2020 to consider urgent items of business, including Cabinet, Planning and Corporate Performance and Resources Scrutiny Committee.
- 1.5 In line with the Local Authorities (Coronavirus)(Meetings)(Wales) Regulations 2020 as amended, Regulation 6 provides that for Principal Councils that had not held their Annual Meeting on or after 1 March 2020 and before the Regulations came into force (which was 22 April 2020) that the Annual Meeting is to be held 'on such day in 2020 as the proper officer of the Council may fix'. The proper officer for these purposes is the Managing Director.
- 1.6 The meeting schedule will therefore reconvene as of the 01st September, 2020 but will also include an intention to hold a full Council Annual Meeting on the 14th September, 2020 which replaces the Annual Meeting that was unable to be held in May 2020 (as per Appendix A).

## 2. Key Issues for Consideration

- 2.1 The previously agreed timetable reflected arrangements that existed pre-COVID-19 and as in previous years, various recesses had been incorporated during August and Easter. As a result of the recesses and taking into account other Bank Holidays and school holidays, on occasions, cycles will vary and / or more than one meeting will occur on the same day. Arrangements for meetings of the Welsh Church Act Estates Committee and the Trust Committee will be dealt with separately.
- 2.2 Given the impact of Covid-19 and the need to ensure the health and safety of members, officers and the public, the form that the meetings will take will be determined closer to the date of each meeting and may well change during the course of the year. Due to the present requirement of the 2-meter social distancing rule, many meeting rooms will be unable to accommodate normal meeting seating layouts and accordingly remote attendance is encouraged, supported by Remote Meeting Guidelines which are being prepared for each meeting type. It is likely that in the Autumn, meetings will be held virtually, with a move to actual meetings being held in the Council Committee rooms and Council chamber being informed by Welsh Government guidance and the Council's own Recovery planning.

# 3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?

**3.1** The Council's Timetable of Meetings directly contributes to the long-term future by ensuring that the Council's decision - making processes continue to operate on a planned basis and to also ensure that the Council's Constitution continues to operate with full effect.
