Executive Summary:

- To seek Cabinet approval and any comments in respect of reports affected by the COVID-19 pandemic for the quarter April to June 2020.
- To note reports that were considered by Cabinet in July 2020.
- To seek Cabinet approval of the updated Cabinet Quarterly Forward Work Programmes from July to September and October to December 2020 in order to bring the Work Programmes back in line with quarterly reporting requirements.
- To agree an Annual Strategic Work Programme from September 2020 to April 2021 with the resumption of meetings following the COVID-19 outbreak to bring reporting requirements back in line for the remainder of 2020/2021.

#### Recommendations

- **1.** To note that usual Cabinet business had been affected by the COVID-19 pandemic since the suspension of meetings on 23 March, 2020.
- 2. To note that the suspension of the Work Programme due to COVID-19 affected Cabinet consideration of any formal Cabinet Quarterly Work Programme for the period April to June 2020.
- 3. That the Cabinet Quarterly Work Programme for July to September 2020 (Appendix 1) be endorsed and reports considered at meeting of Cabinet in July 2020 be noted.
- **4.** That the Cabinet Quarterly Work Programme for October to December 2020 (Appendix 2) be endorsed.
- 5. That the Annual Strategic Cabinet Work Programme for the remainder of the current year 2020/2021 (Appendix 3) be agreed and uploaded to the Council's website.

#### **Reasons for Recommendations**

- **1.** To note that usual Cabinet business had been affected by the COVID-19 pandemic since March 2020.
- 2. To note it was not possible to consider a formal Cabinet Quarterly Work Programme for the period April to June 2020 as a result of the suspension of meetings on 23 March, 2020.
- 3. To approve the Work Programme for July to September 2020.
- 4. To approve the Work Programme for October to December 2020.
- **5.** To comply with the requirements of the Local Government Act 2000, subordinate legislation and the Council's Constitution in setting annual work programmes.

#### 1. Background

- 1.1 At the Cabinet meeting dated 23rd March, 2020, Cabinet considered a 'Coronavirus Preparations, Officer Delegations and Council Working / Business Continuity' report which dealt with temporary emergency Governance arrangements implemented to ensure business continuity within the Council as a result of the implications of COVID-19 pandemic.
- **1.2** As a result of the implications of COVID-19, the Leader and Chairmen of Council Committees on 16th March, 2020 agreed that all meetings of the Council except for Cabinet on 23rd March, 2020 be cancelled for the foreseeable future.
- **1.3** The timetable of meetings for the Municipal Year that was discussed at the Cabinet Meeting on the 20th January, 2020 was subsequently suspended.
- **1.4** As such, the Cabinet Quarterly Work Programme and Annual Strategic Cabinet Work Programme were suspended as well as other specific items that the Executive and Council were planning to consider during the period up to September 2020.

- 1.5 Items that could not wait for the timetable of meetings to reconvene and were considered urgent as a result of the COVID-19 pandemic were dealt with using the Managing Director's Emergency Powers and decisions taken under Emergency Powers had been in line with the Cabinet report of the 23rd March, 2020 and regularly published on the Vale of Glamorgan Council website.
- 1.6 At its meeting of the 27<sup>th</sup> July, 2020 Cabinet considered a 'Reinstatement of Timetable of Meetings: September 2020 to May 2021' report (Minute No. 311) and agreed that the Timetable of Meetings that had been suspended as a result of the COVID-19 pandemic be re-instated from September 2020, subject to any future changes in arrangements for meetings deemed appropriate by the Mayor of the Council or the relevant Committee Chairman.
- 1.7 In accordance with the provisions of the Local Government Act 2000 and the Council's Constitution, the Cabinet Annual Strategic Forward Work Programme sets out matters which the Executive and Council are likely to consider during the period May 2019 to April 2020. The annual programme that would have ordinarily been considered by Cabinet in April 2020 but was suspended as a result of the COVID-19 pandemic which details of the programme for the remainder of the year 2020/2021 has been attached at Appendix 3.
- **1.8** The Forward Work Programme contains information on:
  - The timetable for considering the budget and any plans forming part of the Policy Framework and requiring Council approval, and which body is to consider them;
  - The timetable for considering any plans which are the responsibility of the Executive; and
  - Any individual matters which the Executive intends to consult on, in advance of taking any decision, and the timetable for consultation and decision.

### 2. Key Issues for Consideration

- 2.1 The intention of the Cabinet Forward Work Programme is to ensure clear correlation with the programming of the work of Scrutiny Committees and the Council's Corporate Management Team.
- 2.2 Appendix 1 to the report details a Quarterly Work Programme for July to September 2020 which includes details of decisions taken during urgent Cabinet meetings held in July 2020, items that are included in the Annual Strategic Work Programme as well as other more specific items that the Executive are likely to consider during September 2020.
- 2.3 Appendix 2 to the report details a Quarterly Work Programme for October to December 2020, items that are included in the Annual Strategic Work Programme as well as other more specific items that the Executive are likely to consider during October to December 2020.

2.4 Appendix 3 to the report sets out the current Annual Strategic Forward Work Programme which was unable to be agreed and published in May due to the suspension of the meeting timetable due to COVID-19 and following consideration/approval of Appendices 1, 2 and 3 will be uploaded to the Council's website.
