C611 MINUTES –

RESOLVED – T H A T the Part I minutes of the meeting held on 21st June, 2021 be approved as a correct record.

C613 CARDIFF AND VALE TEST TRACE PROTECT SERVICE SUPPORTING ETHNIC MINORITY COMMUNITIES (DL/ER) (SCRUTINY – LEARNING AND CULTURE) (REF) –

The reference from the Learning and Culture Scrutiny Committee of 10th June, 2021 was presented to Cabinet as contained within the agenda.

The Leader in referring to the reference, drew attention to:-

- The significant amount of work carried out by Vale of Glamorgan Officers in conjunction with external partners (Health, Police, etc.);
- The work of the Shared Regulatory Services (SRS) which had been exemplary.

The Deputy Leader and Cabinet Member for Education and Regeneration had been present at the meeting and had praised the Communications Manager and the Head of Policy and Business Transformation for their work on the whole agenda across the region. Work was ongoing as part of the Test, Trace, Protect service to contact those in the community who were within groups that were not coming forward for vaccinations compared to some others.

Councillor Williams said that a great deal of work had been carried out to reach such a diverse population within the Vale of Glamorgan and Cardiff by SRS.

The reference from the Corporate Performance and Resources Scrutiny Committee of 16th June, 2021 was presented to Cabinet as contained within the agenda.

The Leader asked Cabinet to note the reference at this stage as the comments made within the reference had also been incorporated into the Cabinet report listed as Item 12 on the Cabinet agenda.

C616 CARDIFF BAY ADVISORY COMMITTEE –

The minutes of the Cardiff Bay Advisory Committee held on 2nd June, 2021 as contained within the agenda were submitted.

- An interesting discussion concerning pollution incidents and investigations;
- The repair and reopening of the sluice gates for migratory fish.

The Deputy Leader and Cabinet Member for Education and Regeneration had been present at the meeting and congratulated Councillor Parker for being re-appointed as Chair for another year.

C617 CLOSURE OF ACCOUNTS 2020/21 (L/PR) (SCRUTINY – CORPORATE PERFORMANCE AND RESOURCES) –

The report advised that the year-end revenue position was breakeven after net transfers to reserves of £12.206m, made up of £946k drawn down from the Council Fund and £13.152m transferred into specific reserves. The Council Fund now stood at £11.868m as at 31st March, 2021.

A revenue savings target of £247k was set for 2020/21 and this target was achieved in the year.

The Housing Revenue Account was also able to increase the level of its ringfenced reserve to £12.0m after achieving a £4.052m surplus.

There was capital expenditure during the year of £78.360m which required funding of £2.745m to be drawn down from reserves.

The Leader said that the year end revenue position was reflective of some transfers into the reserves as a result of the pandemic and some additional Welsh Government funding for schools, etc.

The Housing Revenue Account increase was largely as a result of the pandemic and Officers not being able to carry out work in tenant's houses as a result of COVID-19 restrictions.

The last year had been particularly difficult as a result of the pandemic, and Welsh Government had supported all Local Authorities with additional funding as described in the report.

The Deputy Leader and Cabinet Member for Education and Regeneration said that the report would also be considered at Learning and Culture Scrutiny Committee on the 8th July, 2021 as well as other Committees and Cabinet Members would be available to discuss and address any matters in depth as required at each meeting as part of ongoing detailed discussions before the final report was submitted to full Council.

This was a matter for Executive decision.

C618 REVENUE MONITORING FOR THE PERIOD 1ST APRIL TO 31ST MAY, 2021 (L/PR) (SCRUTINY – CORPORATE PERFORMANCE AND RESOURCES) –

The report advised that the revenue position for 2021/22 would continue to be challenging for the Council both operationally and financially due to the ongoing implications of the COVID-19 pandemic. This impacted both as a result of incurring additional expenditure but also from a loss of income.

Confirmation had been received from Welsh Government that funding to cover some of the issues would be received up to 30th September, 2021.

An efficiency target of £500k had been set for the year and services were currently working towards achieving their targets. There were some issues remaining relating to unachieved savings targets from previous years.

Adverse variances were being projected for some services this year and the use of reserves would be required to resolve those issues in the short term.

The Leader said that the issuing of the £735 payment in relation to the financial recognition for the Social Care Workers scheme had already started.

This was a matter for Executive decision.

C619 CAPITAL MONITORING FOR THE PERIOD 1ST APRIL TO 31ST MAY, 2021 (L/PR) (SCRUTINY – CORPORATE PERFORMANCE AND RESOURCES) –

The report provided an update on the progress of the Capital programme for the period 1st April to 31st May, 2021. Details by scheme are shown in Appendix 1.

The report set out requested changes to the 2021/22 and future years' Capital Programme.

The Deputy Leader and Cabinet Member for Education and Regeneration said that over the last week she had been signing off the tenders for schools maintenance to take place over the summer holidays, and was pleased to see work being assigned to local businesses or those close to the Vale of Glamorgan in order to boost the local economy.

- Flying Start Capital Grants - Increase the 2021/22 Capital Programme by £150k to be funded by a grant from Welsh Government.
- Social Services ICF Capital Grants - Increase the ICF Ty Dyfan and Cartref Dementia Improvements budget in the 2021/22 Capital Programme by £244k of internal monies carried forward from 2020/21.
- Resource Recovery Facility (Waste Transfer Station) - Increase this scheme by £857k in the 2021/22 Capital Programme to be funded from a Welsh Government Grant.
- Circular Economy - Reuse Shop - Increase this scheme by £30k in the 2021/22 Capital Programme, to be funded from the Neighbourhood Services & Transport reserve.
- Transport grants - Include grant schemes totalling £2.907m (detailed in paragraph 2.19 below) onto the 2021/22 Capital Programme to be funded from Welsh Government grants.
- Highway Refurbishment - Include a budget of £755k in the 2021/22 Capital Programme to be funded by a grant from Welsh Government.
- Small Scale Work Grant - Include a budget of £237,379.50 into the 2021/22 Capital Programme to be funded by a grant from Welsh Government and to vire £41,890.50 from the Flood Risk Management budget to this budget.
- ICF - Penarth Older Persons Village - Increase the ICF - Penarth Older Persons Village budget in the 2021/22 Capital Programme by £300k of internal monies carried forward from 2020/21.
- Local Nature Partnership Cymru Grant - Increase this budget by £50k to be funded by a grant.

- Access Improvement Grant - Increase the 2021/22 Capital Programme by £62,098 to be funded by a grant from Welsh Government.
- Building Strong Communities Fund - Increase Building Strong Communities Fund scheme in the 2021/22 Capital Programme by £26.5k to be funded from the Stronger Communities revenue budget.
- Hwb Programme - Increase the 2021/22 Capital Programme by £1,015k to be funded £712k grant from Welsh Government, £100k revenue contribution from schools and £153k contribution from the Policy revenue budget and a virement of £50k from the ICT allocation scheme already included in the 2021/22 Capital Programme.

(5) T H A T the following changes to the 2021/22 and future years Capital Programme be approved:-

- Band B Schemes - Reprofile the Band B schemes as set out in the table in paragraph 2.10, and to increase the overall budget by £900k to be funded from Welsh Government grant.

- Llanmaes Flood Risk Management - Increase this scheme budget by £66k match funding which will be funded from the Neighbourhood Services and Transport reserve.
- HRA New Build- Bring forward £100k from the 2022/23 Capital Programme into the 2021/22 Capital Programme.
- Neighbourhood Services Asset Renewal including toilets, signage and benches - Vire £7k to the Coastal Infrastructure budget.
- Penarth High Level Glazing - Vire £120k of the Leisure Centre works scheme to the Penarth High Level Glazing scheme budget in the 2021/22 Capital Programme.
- Improvement works to the footpath infrastructure on Old Port Road, Wenvoe - Increase this budget to £13.5k in the 2021/22 Capital Programme to be funded from s106 monies.
- ENABLE Grant - Include this scheme on the 2021/22 Capital programme with a budget of £177,320 to be funded by a grant from Welsh Government.
- WLGA Food Poverty Grant - Increase this scheme by £28,859 in the 2021/22 Capital Programme to be funded by a grant from the Welsh Local Government Association.
- Goodshed Repayment to Welsh Government - Increase the Capital Programme by £200k (£100k in 2021/22 and £100k in 2022/23) to be funded from capital receipts.

C620 CABINET QUARTERLY WORK PROGRAMMES – APRIL TO JUNE 2021 AND JULY TO SEPTEMBER 2021 (L/PR) (SCRUTINY – CORPORATE PERFORMANCE AND RESOURCES) –

The report sought Cabinet approval and any comments in respect of the progress update for the quarter April to June 2021 and the updated Cabinet Quarterly Forward Work Programme from July to September 2021.

The Leader said that for the quarter April to June 2021, the majority of reports had been completed with only one or two deferred as a result of the pandemic to a future Cabinet meeting.

This was a matter for Executive decision.

C621 PROJECT ZERO - DRAFT CLIMATE CHANGE CHALLENGE PLAN (L/PR) (SCRUTINY – CORPORATE PERFORMANCE AND RESOURCES) –

The report advised that the draft Climate Change Challenge Plan set out the Council's response to the climate emergency and the work that would be undertaken as part of Project Zero.

The draft plan detailed eighteen challenges and the steps the Council proposed to take to meet those challenges as part of Project Zero. Those challenges were framed around the need to demonstrate strong leadership, fulfil our responsibility to current and future generations and to make a difference now.

The draft plan also detailed some of the work already underway across the Council as part of work to adapt to and mitigate the impact of climate change. That work also formed part of Project Zero.

The report detailed the consultation undertaken on the draft Plan, the resulting feedback and revisions to the Climate Change Challenge Plan.

The report also detailed some of the ongoing engagement as part of Project Zero and the recent Welsh Public Sector net zero guidance issued by Welsh Government to calculate carbon emissions.

The report also set out the timetable for the plan being approved and endorsed by Council.

Consideration of the revised Plan by Environment and Regeneration Scrutiny Committee and Corporate Performance and Resources Scrutiny Committee as attached at Appendices C and D were duly noted and the resolutions agreed by Cabinet.

The Deputy Leader and Cabinet Member for Education and Regeneration said that it had been two years since the Motion to Council to declare a climate emergency and a great deal had happened since that time, not least a pandemic. Councillor Burnett was pleased with the partnership working relationship with the Public Services Board.

The pupils of Barry Island Primary School had already questioned Cabinet Members and made suggestions for consideration, and a number of schools already had their own plans and projects in place. They also had a dashboard they could use to monitor carbon usage within their own schools and levels of engagement had been positive across the Vale of Glamorgan.

This was a matter for Executive decision.

C622 CORONAVIRUS UPDATE (L/PR) (SCRUTINY – CORPORATE PERFORMANCE AND RESOURCES) –

The report provided Cabinet with a high-level overview of the current position regarding coronavirus and the Council's current arrangements to respond and recover from the pandemic.

The report also provided an update on the latest position for Council services and the regional arrangements for managing the public sector response to the pandemic, and specific aspects of this, including mass vaccinations and the Test, Trace, Protect service.

The Council's Recovery Strategy adopted in late 2020 had provided a framework for progressing the strategic recovery of the organisation and an update on this was included for Members' information and consideration, alongside the results from the recent staff well-being survey.

It was recommended that Cabinet refer the report to Corporate Performance and Resources Scrutiny Committee with regards the Council's approach to managing the impact of the pandemic and to the Governance and Audit Committee as further contextual information when considering the Corporate Risk Register. Given the importance of the report, it was also recommended that the report be shared with all Elected Members and the Council's Public Services Board partners for their information.

The Leader advised that since 23rd June the national position had changed and drew attention to the latest position as of 5th July as below:

- As at 5th July, 2021, the latest coronavirus data that was available for the rolling seven days showed 123 new cases had been diagnosed in the Vale of Glamorgan, with a case rate of 53.3 per 100,000 of population;
- As at 5th July, 2021, the positive proportion of tests carried out was 5.4%;
- As at 5th July, 2021, the comparator figures for Wales was 3,015 cases with a case rate of 41.2 per 100,000 of population and the positive proportion of tests carried out being around 5%;
- This was a significant increase in recent weeks as coronavirus measures had been eased;
- The Delta variant was now the most prevalent in Wales;
- Current hospital admissions were not very high and those affected did not seem to require previous levels of hospital treatment, but hospitals were feeling the strain of levels usually associated with winter for diagnosis and treatment which had not been possible during the height of the pandemic;
- The Leader encouraged anyone who had not had a vaccination to do so in order to protect themselves and those around them;
- The current surges in those affected were within the 10-29 age groups, suggesting it was not as severe amongst the older population, but the younger generation were still capable of passing it on.

This was a matter for Executive decision.

C624 CORPORATE ASSET MANAGEMENT PLAN ANNUAL UPDATE (L/PR) (SCRUTINY – CORPORATE PERFORMANCE AND RESOURCES) –

The report communicated the progress made throughout 2020/21 against five objectives and additional targets contained within the Corporate Asset Management Plan 2019-2022 (more specifically detailed in the table at Appendix A).

The report also provided Cabinet with an overview of the work that had been undertaken in relation to property assets following the outbreak of the coronavirus pandemic.

The COVID-19 pandemic had meant that some actions had to be delayed, however others had been accelerated to reflect the urgency of certain asset related decisions. New work streams and projects had been established to respond to the specific requirements associated with the pandemic as they had arisen.

The Deputy Leader and Cabinet Member for Education and Regeneration said that the Property Team had been available throughout the pandemic and passed on her thanks to all staff for all their work over the last fifteen months working within difficult circumstances. The Leader proposed an additional recommendation to reflect thanks from Cabinet to all staff who carried out such functions and made sure the Asset Management Plan continued to function despite the pandemic, as well as carrying out staff surveys.

This was a matter for Executive decision.

With the addition of Recommendation (4), Cabinet, having considered the report and all the issues and implications contained therein

C625 CONSULTATION RESPONSE: WELSH GOVERNMENT'S RACE EQUALITY ACTION PLAN FOR AN ANTI-RACIST WALES (L/PR) (SCRUTINY – CORPORATE PERFORMANCE AND RESOURCES) –

The report summarised key aspects of the Welsh Government's draft Race Equality Action Plan for an Anti-Racist Wales (REAP) and brought to the attention of the Cabinet a draft response to the consultation on the Plan (Appendix A).

The Welsh Government had issued a consultation document outlining draft proposals for a Race Equality Action Plan with many actions relevant to Local Authorities. This was informed by research, existing evidence, engagement with community leaders and stakeholders, and shaped by people's lived experience.

The Welsh Local Government Association (WLGA) has produced a document (Appendix B to the report) highlighting where there would be work for Local Authorities.

To inform the Council's draft response to the consultation, comments from officers across Council Services, the Ethnic Minority Staff Network and the Equalities Consultative Forum had been sought. These had been incorporated in the draft response (Appendix A to the report).

The consultation period ends on 15th July, 2021.

Councillor Gray said the report contained important messages. He had attended the Welsh Government consultation launch event and a wide array of organisations and ethnic minorities were in attendance from across Wales. They had been uniform in agreeing that that was the right message and direction and it was up to all concerned to commit to making the country anti-racist. It was important to engage and debate the issues and felt the response was comprehensive.

Councillor Burnett looked forward to the Learning and Culture Scrutiny Committee being able to give the report due consideration. She had taken the education consultation response to a meeting of the Education Cabinet Members in the Consortium and the contributions were a catalyst for discussion and hoped that the same would be the case at Scrutiny Committee.

The Leader said that similarly to Project Zero, this would be an ongoing matter for discussion.

Councillor Williams said he had attended the Ethnic Minority Group in the Vale of Glamorgan where there had been a diverse range of attendees who were positive

and constructive about the need for change and was interested to hear alternative points of view being put forward.

This was a matter for Executive decision.
