Name of Town/Community Council: COLWINSTON

It is requested that the Community Liaison Committee consider the following matter. (N.B. Items that are site specific should be referred to the appropriate Council department):

Brown Signage on the A48 - request to review the Vale of Glamorgan Council Brown Signage Policy.

Reason(s) for request:

For some considerable time the Community Council has been trying to improve the signage to the village pub, the Sycamore Tree Inn. The pub, a focal point of the local community is not signposted from the A48, which adversely effects the business and sustainability of the pub/restaurant.

Recently, the VOGC proposed a revised sign into the village i.e. from the A48, which would incorporate a 'knife and fork' symbol in the style of a brown information sign. However, the VOGC will only install the sign if it is paid for by the pub at a cost of £2,000.00.

The pub, as have many in the last year, has been closed due to the pandemic and cannot afford the fee. The business has been hit very hard. Pubs generally are struggling to survive and once lost are very difficult to replace.

The VOGC's policy in respect of road signage is designed to prevent the proliferation of road signage to avoid 'clutter'. Those using the excellent new 'five-mile lane' (as an example) may be surprised that such a policy actual exists as this road contains a myriad of signs, some of a size normally associated with motorways or major A roads.

The signage on this road, which includes brown signs for local pubs, is not compatible with its rural setting, and there is little evidence that a policy aimed at reducing signage-clutter has been applied. Yet, the VOGC has determinedly, declined several request for one new sign on the A48, which would support a local community business at a now crucial time.

The justification for this stance is the aforementioned policy. Yet this policy is

out of date and its scheduled review is long overdue. Consequently, it can be argued that it does not apply.

The Community Council would, therefore, like the Liaison Committee to request an urgent review of this policy and to support the application of a policy that considers local context and the support of businesses that provide an important role in isolated rural communities such as Colwinston. In the interim, officers of the VOGC should be given the authority, and a budget, to use their discretion to assess such cases on their merits, rather than simply applying a now out of date policy.
