Report Title:	Renewal of Public Space Protection Orders - Dog Controls
Purpose of Report:	To ensure there remains effective controls and management arrangements in place, aimed at improving the behaviour of irresponsible dog owners and reducing anti-social behaviour associated with dogs and dog fouling.

<p>Executive Summary:</p> <ul style="list-style-type: none"> • The Report seeks approval to renew with variations the existing Public Space Protection Orders (PSPO's), for the purpose of dog controls. • Cabinet is requested to agree the new Orders in principle and refer the Report to Full Council for consideration. • Maps featuring full details of all the controls will be available on the Council's website and incorporate the proposed changes and where practical, locations will feature new clear signage explaining the locations of the controls and the implications for any infringements. • The Report features an addition of a new Order covering all adopted Highways and Footways, with a requirement for all dog owners to pick up all instances of dog fouling in line with Legislation. • The PSPO would be launched with a comprehensive media campaign aimed at improving the behaviour of irresponsible dog owners and reducing future incidence of anti-social behaviour. 	

- The Council has undertaken a public consultation exercise in respect of the renewal of these Orders and an over whelming majority of respondents (85.3%) wanting to see the Orders renewed.

Recommendations

1. That Cabinet endorses the proposal of renewing the existing Public Space Protection Orders for dog controls.
2. That Cabinet notes the contents of the public consultation results.
3. That Cabinet agrees to include the proposed, new additional areas as part of the renewal process and to incorporate these into the Orders for Full Council consideration.
4. That the resolutions of Cabinet in respect to this report are referred to Full Council for consideration.
5. That use of the urgency procedure set out at Section 15.14 of the Council's Constitution be agreed in respect of recommendations 1, 2, 3 and 4 to allow the matter to be considered at Full Council on 15th July, 2024.

Reasons for Recommendations

1. So the Council has robust Orders in place for dog controls on adopted highways, footpaths, resorts/beaches, town centres, sports pitches, and public open spaces.
2. To ensure the Council considers the view of the public and other stakeholders and the Orders reflect current issues.
3. To ensure the Council has appropriate powers to protect the quality of lives of those who live, work and visit the Vale.
4. The renewal and introduction of Public Space Protection Orders are a matter for determination by Full Council.
5. To ensure the Orders can be considered at the next Full Council meeting and if agreed, promptly introduced following the meeting.

1. Background

- 1.1 Council on 10th March, 2021 (Minute no C623 refers) approved the existing Public Space Protection Orders (PSPO'S) for dog controls, for a 3-year period to replace previous Bye Laws and Legislation, made under the Criminal Justice and Police Act 2001.

- 1.2 The Anti-Social Behaviour, Crime and Policing Act 2014 (the Act) provides local authorities with a set of powers, including PSPOs, to prevent and reduce a range of anti-social behaviours and other issues in public spaces which have a negative

or detrimental impact on the local community and the local community's quality of life.

- 1.3** The purpose of the existing PSPO is to provide the Council with proportionate and robust Orders to ensure residents and visitors can safely use and enjoy public spaces, free from anti-social behaviour (ASB) associated with dogs and dog fouling.
- 1.4** The Council currently has limited powers for managing anti-social behaviour associated with dogs on public land as previous legislation such as Byelaws and the Dogs (Fouling of Land) Act 1996 have been superseded by PSPO's.
- 1.5** Legislation exists, but offenders are not able to discharge their liability for the offence via a fixed penalty notice. In such cases the Council must progress each case via prosecution through the Courts which is not necessarily always practical.

2. Key Issues for Consideration

- 2.1** The existing PSPO's for dog controls expired in March 2024 and this report proposes to renew those existing Orders with amendments.
- 2.2** The renewal of the existing Orders is subject to public consultation. The Council has a statutory duty to consult when proposing to introduce PSPO's and when renewing them every 3-years.
- 2.3** Although s.72 of the Act does not declare a length of time in terms of a consultation period, the previous consultation exercise was undertaken for 12-weeks which is deemed reasonable as they were new, first time Orders.
- 2.4** The consultation in respect of renewals is usually a minimum of 6-weeks but this process, on this occasion, exceeded 3-months. There were internal discussions between teams and stakeholders from early December 2023 until the end of January 2024 and the formal public consultation opened 8th February, 2024 and ran for 7-weeks until 25th March, 2024.
- 2.5** There was a dedicated consultation page hosted on the Council's engagement platform, Participate Vale throughout the consultation period and those who could not complete an online survey were able to request hard copies or share their views by calling 01446 700111. Written responses were also welcomed.
- 2.6** The consultation was promoted on social media and through emails to stakeholders listed below, including the 5,000 residents who have subscribed to receive emails regarding any consultations undertaken by the Council.

- 2.7** The consultation relating to the dog controls survey received 218 responses as well other written responses.
- 2.8** There was one from a charity who suggested re-considering outright beach bans by allowing dogs on beaches early in the mornings or in the evenings or having dog friendly sections on beaches. This suggestion was due to the number of calls the charity receives relating to dogs left in hot cars whilst their owners visit beaches.
- 2.9** The other suggestion related to dog on lead controls due to a concern about dogs having adequate space to exercise off lead. The suggestion was: 'The Council should ensure that there is an adequate number, and a variety of, well sign-posted areas locally for owners to exercise their dog off-lead.'
- 2.10** There are already such areas, but this needs to be advertised better as well as ensuring there is appropriate signage in place in other areas where controls differ.
- 2.11** Another was from a resident related where other local authorities have introduced Orders in relation to dog owners carrying bags to pick up after their dog. There was also a suggestion that sports pitches should be considered for excluding dogs.
- 2.12** It is proposed to retain the existing arrangements on pitches, but further research undertaken on the requirement to carry bags will be undertaken for future consideration.
- 2.13** Additionally, it is proposed to retain the same broad principles of a dog ban at children's play areas, at certain beaches, dogs on leads in high footfall places only such as specific resorts and pick up dog fouling at all locations.
- 2.14** Another suggested additional bins, including dog fouling bins should be provided throughout the Vale.
- 2.15** From the overall formal consultation exercise, 85.3% of respondents strongly agree or agree that all the existing Orders should be retained.
- 2.16** Additionally, there were new areas proposed as part of the formal consultation exercise. There were as follows:
- All adopted highways and footpaths (remove dog fouling Order)
 - Seasonal beach ban at Ogmores by Sea beach (ban 1st May – 30th September)
 - Common land Ogmores to Southerndown (Dogs on leads Order, in the presence of agricultural animals)
 - Barry Waterfront new play areas/open spaces – Dog ban within children's play areas or dogs on leads where they are not gated, new open spaces – remove dog fouling Order.

- Somerset Road West, Barry - open space (remove dog fouling Order)
- Greenmeadow Way, Rhoose play area – dog ban

- 2.17** An overwhelming majority of respondents agreed with the inclusion of all adopted roads and footpaths. There were no respondents strongly disagreeing or disagreeing with the inclusion and only 4 respondents out of 217 returns neither agreeing nor disagreeing. An overwhelming 98% of all respondents want to see the inclusion of a new control created to removing dog fouling on all adopted highways and footpaths.
- 2.18** Out of 216 respondents, 53% strongly agreed or agreed with the proposal to include Ogmore by Sea as a seasonal beach ban, 14% neither agree or disagree and only 33% strongly disagreed or disagreed with the inclusion.
- 2.19** 80.3% of respondents were local residents, 13% dog owners, under 3.6% were from other areas, under 2.1% were responding on behalf of a group or organisation, and 1% were visitors.
- 2.20** The majority of respondents were female (57.4%), whilst 31.9% were male and 10.6% preferred not to say.
- 2.21** The highest proportion at 25.8% of respondents were in the 55-64 age category, 20.2% of respondents in the 35-44 age category, 19.2% in the 45-54 category, 16.9% in the 65-74. The remaining 8.9% are in the 75+ age category, 8.5% in the 25-34 age range and 0.5% 15-19 category.
- 2.22** There was a lot of feedback relating to dog beach bans for and against dogs being allowed on them. But other than including Ogmore as a result of ongoing poor water quality, the recommendation is to retain the arrangements as per the existing Orders.
- 2.23** Within the area of Ogmore, there was strong support to include dogs on leads in areas that have agriculture animals, and this is proposed as a new Order. The Order will request dogs on leads in the presence of agricultural animals.
- 2.24** There was a detailed list of comments returned from respondents and these are attached along with the full results of the consultation, at **Appendix A**.
- 2.25** The penalty associated with these proposed Orders, include a Fixed Penalty Notice (FPN) or a fine of up to level 2 upon conviction. A total of 6 FPN's issued for dog related offences in the last Orders.
- 2.26** By renewing and creating Orders, it is intended to make public spaces more welcoming to the majority but not restrict activities. The Orders however, should enhance the areas covered by providing clean and safe environments.
- 2.27** The new Order is attached at **Appendix B**, and maps of the new areas at **Appendix C**.

3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?

- 3.1** The Well-being of Future Generations (Wales) Act 2015 is about sustainable development. The Act sets out a 'sustainable development principle' which specifies that the public bodies listed in the Act must act in a manner which seeks to ensure the needs of the present are met without compromising the ability of future generations to meet their own needs. In meeting their sustainability duty, each body must set objectives that highlight the work the body will undertake to contribute to meeting the seven Well-being Goals for Wales.
- 3.2 Long term** – The Orders will safeguard the Council's long-term strategic outlook regarding tourism and ensure it has robust measures to provide safe and secure environments of our citizens and visitors.
- 3.3 Integration** - The introduction of new Orders and the proposal to renew the existing PSPOS's demonstrates an integrated approach to robustly managing our Streets, Resorts, Town Centres and Open Spaces and demonstrates that the Council will not tolerate Anti-Social Behaviour relating to dogs and dog fouling.
- 3.4 Involvement** - By undertaking a comprehensive consultation process involving all our stakeholders it will ensure that citizens and visitors are engaged regarding the management of our Street, Resorts, Town Centres and Open Spaces in respect of Anti-Social Behaviour and the associated Orders.
- 3.5 Collaboration** - The proposals will involve working in collaboration with Town Councils, Community Councils, South Wales Police and Community Support Officers.
- 3.6 Prevention** - Consideration will need to be given as to whether prohibitions in one area will displace the problem behaviour elsewhere, or into a neighbouring Authority.

4. Climate Change and Nature Implications

- 4.1** These Orders aim to reduce the impact of Anti-Social Behaviour associated with dog controls and specifically dog fouling and litter and aims to assist the Council maintain clean and safe public spaces and have a positive impact on our environment.

5. Resources and Legal Considerations

Financial

- 5.1** All Order publications will be provided bilingually, and signs will be created in compliance with the Welsh Language Act 1993.

- 5.2** There will be an approximate cost of £2,500 to produce and install the signs and this will be funded from the relevant revenue budgets.

Employment

- 5.3** There are no employment implications associated with this Report.

Legal (Including Equalities)

- 5.4** The extension of the PSPO's and proposal to vary them by increasing the number of restricted areas covered by them will require approval from Full Council.
- 5.5** The legal authority to make, extend, vary or discharge a PSPO is set out in the Antisocial Behaviour, Crime and Policing Act 2014. The publication of a PSPO is as required by the Anti-Social Behaviour, Crime and Policing Act 2014 (Publication of Public Spaces Protection Orders) Regulations 2014.
- 5.6** The legal test and the two conditions as detailed elsewhere in the report permits a Local Authority to make a PSPO where it is satisfied on reasonable grounds that the two conditions are met pursuant to section 59 (1) and (2) of the Act.
- 5.7** The test requires that the behaviour being restricted must:
- Be having, or likely to have, a detrimental effect on the quality of life of those in the locality; or It is likely that activities will be carried on in a public place within that area and that they will have such an effect.*
- The second condition is that; Is, or is likely to be, of a persistent or continuing nature, Is, or is likely to be, such as to make the activities unreasonable, and Justifies the restrictions imposed by the notice.*
- 5.8** The making of a PSPO must be reasonable to prevent or reduce the detrimental effect of the problem behaviour, or reduce the detrimental effect continuing, occurring or reoccurring.
- 5.9** Necessary consultation must be carried out to include amongst other things a consideration of the scope of the Order, the areas covered, the impact of the proposals and an analysis of how restrictions meet the legal test.
- 5.10** An interested person may appeal to the High Court to question the validity of a PSPO, or a variation of an Order.
- 5.11** A Local Authority is required to have regard to specific restrictions which apply upon the making or variation of a PSPO as set out in 'the Act'.
- 5.12** An interested person may apply to the High Court to question the validity of a PSPO, or a variation of an Order. An appeal must be made within the period of 6 weeks beginning with the date on which the Order or any variation is made.
- 5.13** A Local Authority is required to have regard to Articles 10 and 11 of the Human Rights Act 1998 regarding freedoms permitted of the freedom of expression and freedom of assembly and association.

- 5.14** A local Authority who is satisfied following a necessary consultation that it is reasonable to make, extend, vary, or discharge a PSPO is required to publish the text of it for any variation, and publish the proposal for any extension of it.

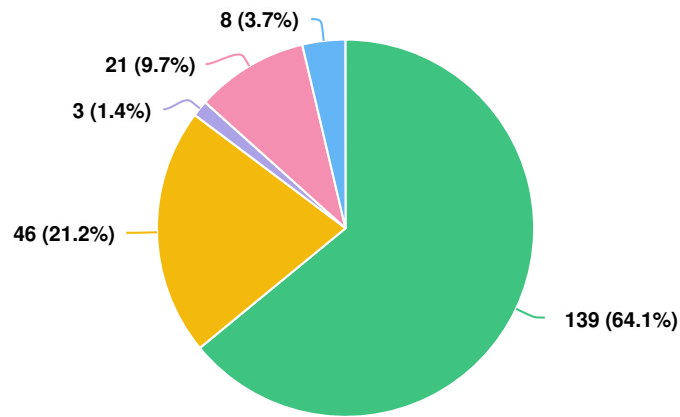

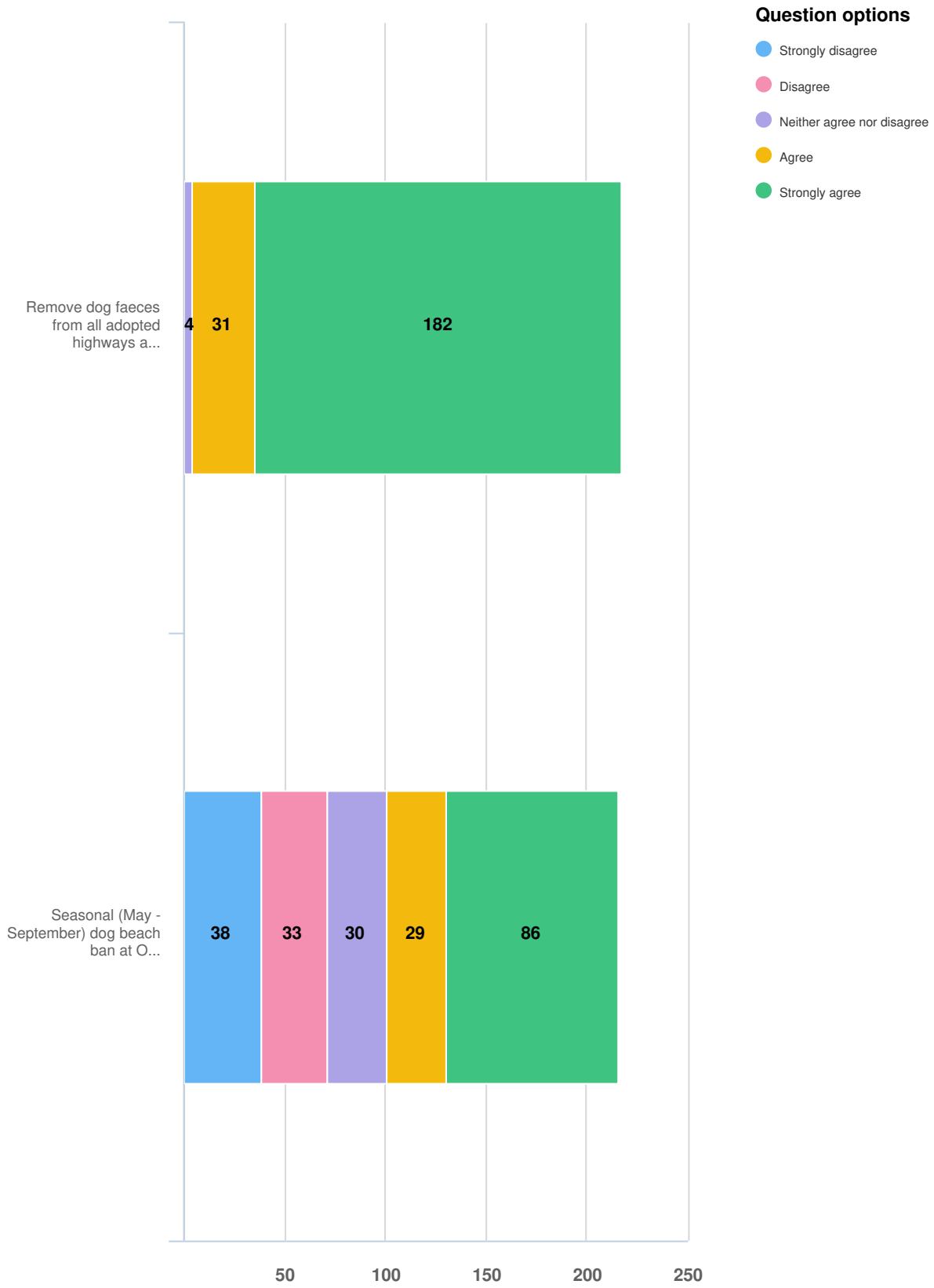

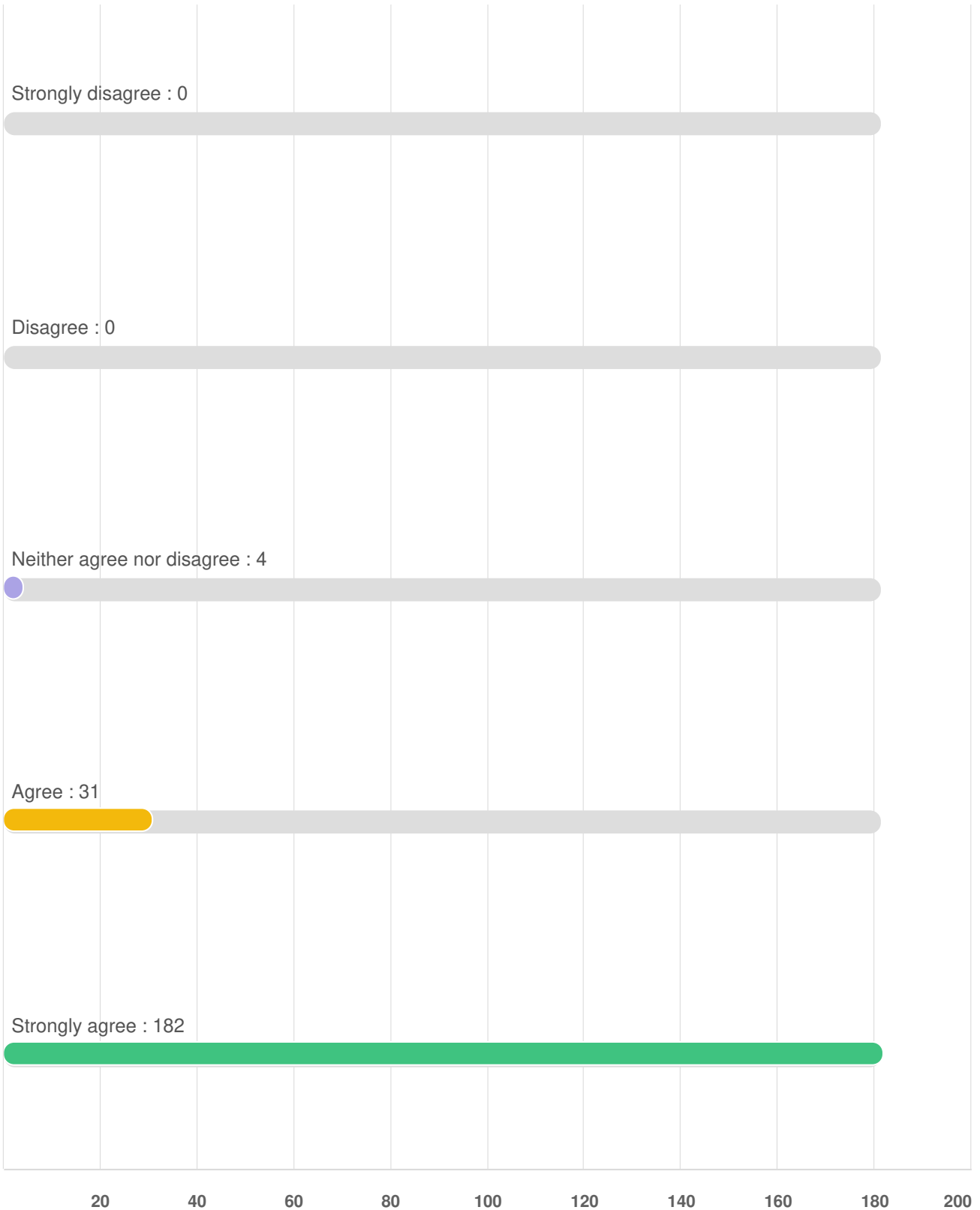
Q2 Do you agree or disagree with the proposal to introduce the following new controls?



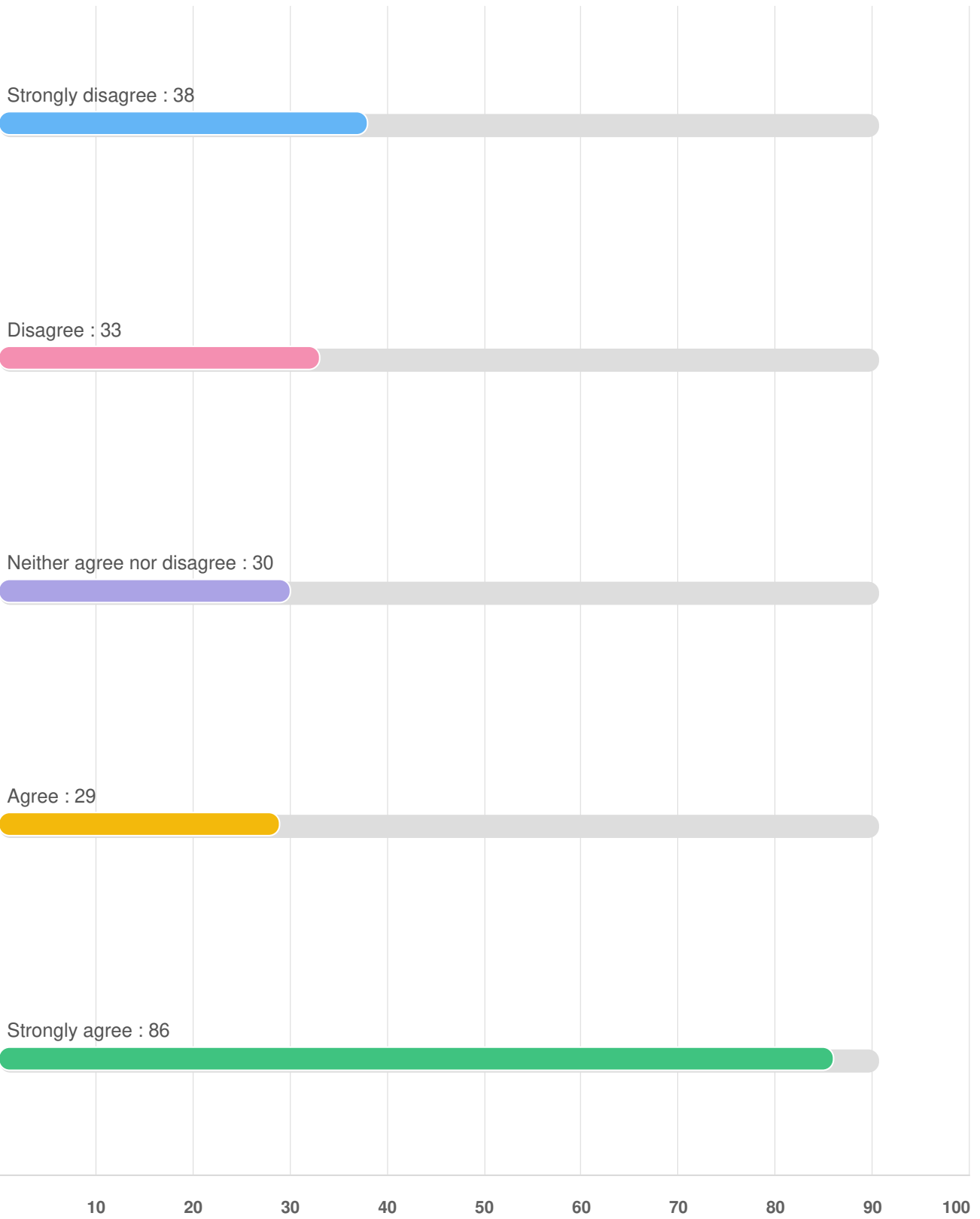

The Vale of Glamorgan Council Enforcement Service would like to see the introduction of controls regarding animal worrying. This is a significant problem in rural areas and particularly in the western-most part of the Vale, where livestock is frequently attacked by dogs not being on leads. Just on 15th February 2024, there was one such incident in Llanmaes involving dogs being walked off lead on a footpath that passes a field. The dogs began to attack the horses. Each year, we receive reports of livestock being injured and even killed by dogs and this is of significant concern to both elected members and the Vale's various smallholders and livestock owners. This cannot continue and especially at locations where livestock is lawfully grazing on Common ground. Existing legislation, such as the Dogs (Protection of Livestock) Act 1953 does not adequately deal with such issues and in any event can only be currently enforced by South Wales Police. They have neither the resources or the requisite knowledge of such legislation to be able to enforce the same effectively. While new legislation in the form of the Kept Animals Bill is many years away from becoming legislation, the Vale's livestock and indeed dogs themselves are at significant risk of injury and death until that time. A control, within the PSPO, that effectively deals with animal worrying needs to be included.

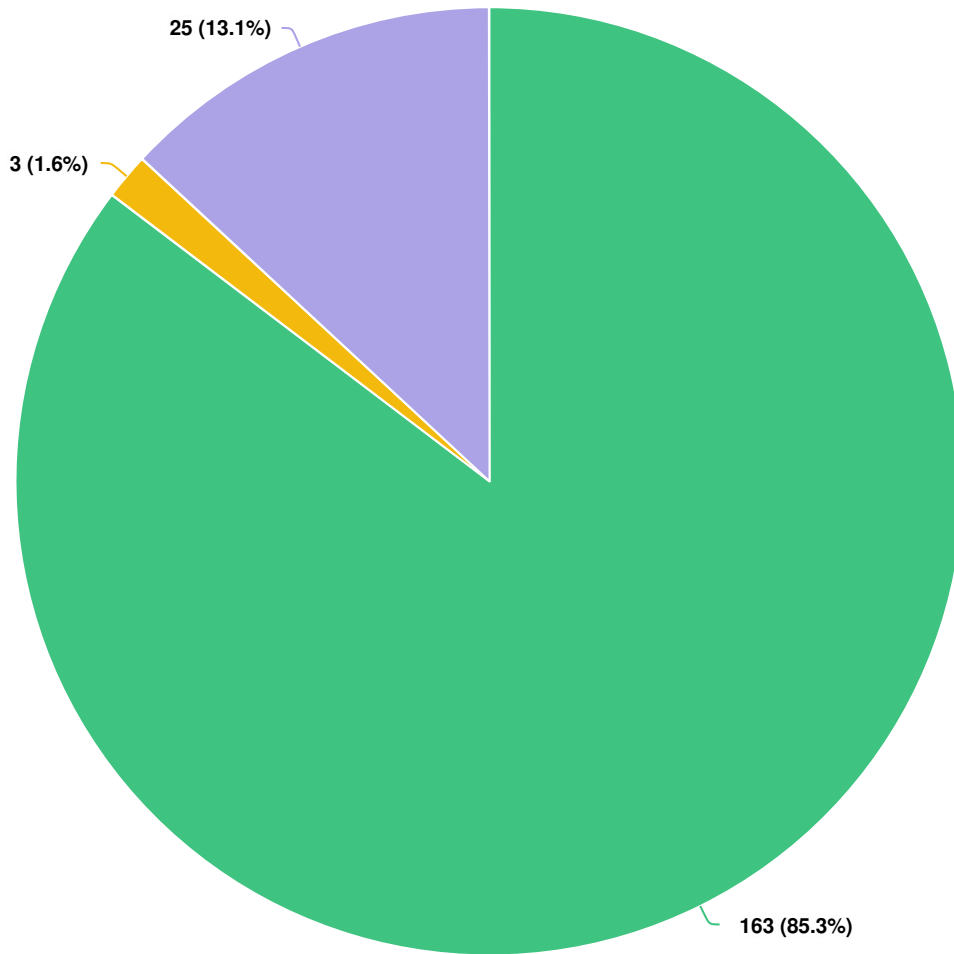

PUBLIC SPACE PROTECTION ORDER 2021

ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT 2014

The Vale of Glamorgan Council (the Council) in exercise of its powers under Sections 59 and 72 of the Anti-social Behaviour, Crime and Policing Act 2014 (the Act) and under all other enabling powers, hereby makes the following Order:

1. This Order shall come into effect on **15th July 2024** and shall have an effect for 3 years thereafter, unless extended by further Orders under the Council's statutory powers.
2. This Order relates to the specified areas listed in the below Schedule.
3. The Council is satisfied that the conditions set out in Section 59(2) of the Act have been met. Namely that anti-social behaviour relating to irresponsible dog ownership has been carried out within the specified areas. This behaviour has a detrimental effect on the quality of life of those in the locality, and it is likely that these activities will be carried out within that area and has such effect.
4. The Council is also satisfied that the conditions set out in Section 59(3) of the Act have been met. Namely, that the effect or likely effect of the activities is, or is likely to be, of a persistent or continuing nature and that these activities are unreasonable and justify the restrictions imposed by this Order and that it is in all the circumstances expedient to make this Order for the purpose of reducing crime and/or anti-social behaviour in a public place.

Restrictions

1. The effect of this Order is to impose the following conditions on the Restricted Area:
 - 1.1 In the Restricted Area a person commits an offence if without reasonable excuse does not comply with the following requirements/prohibition and/or directions, namely;
 - 1.1.1 An owner and or a person in control of a dog must remove the dog's faeces from the land in accordance with the Public Spaces Protection Order.
 - 1.1.2 An owner and or a person in control of a dog must not permit a dog to enter a restricted area in accordance with the Public Spaces

Protection Order including areas with seasonal restricted area between 1st May and 31st September [seasonal restrictions].

- 1.1.3 An owner and or a person in control of a dog must ensure that it is on a lead and they are in control of the dog in a restricted area in accordance with the Public Spaces Protection Order.
2. An 'Authorised Officer' can be a Council employee, a person designated by the Council, a Police Officer or Police Community Support Officer who is authorised in writing by the Vale of Glamorgan Council for the purposes of giving directions under this Order.

Fixed Penalty Notice and Offences

1. It is an offence for a person without reasonable excuse to engage in the activities restricted, prohibited or requirements in this Order.
2. In accordance with Section 67 of the Act, a person found to be in breach of the requirements /prohibitions or directions of this Order on summary conviction to a maximum penalty of a level 3 fine.
3. An authorised person may issue a Fixed Penalty Notice to the value of £100 to a person they have reasonable grounds to suspect has committed an offence.

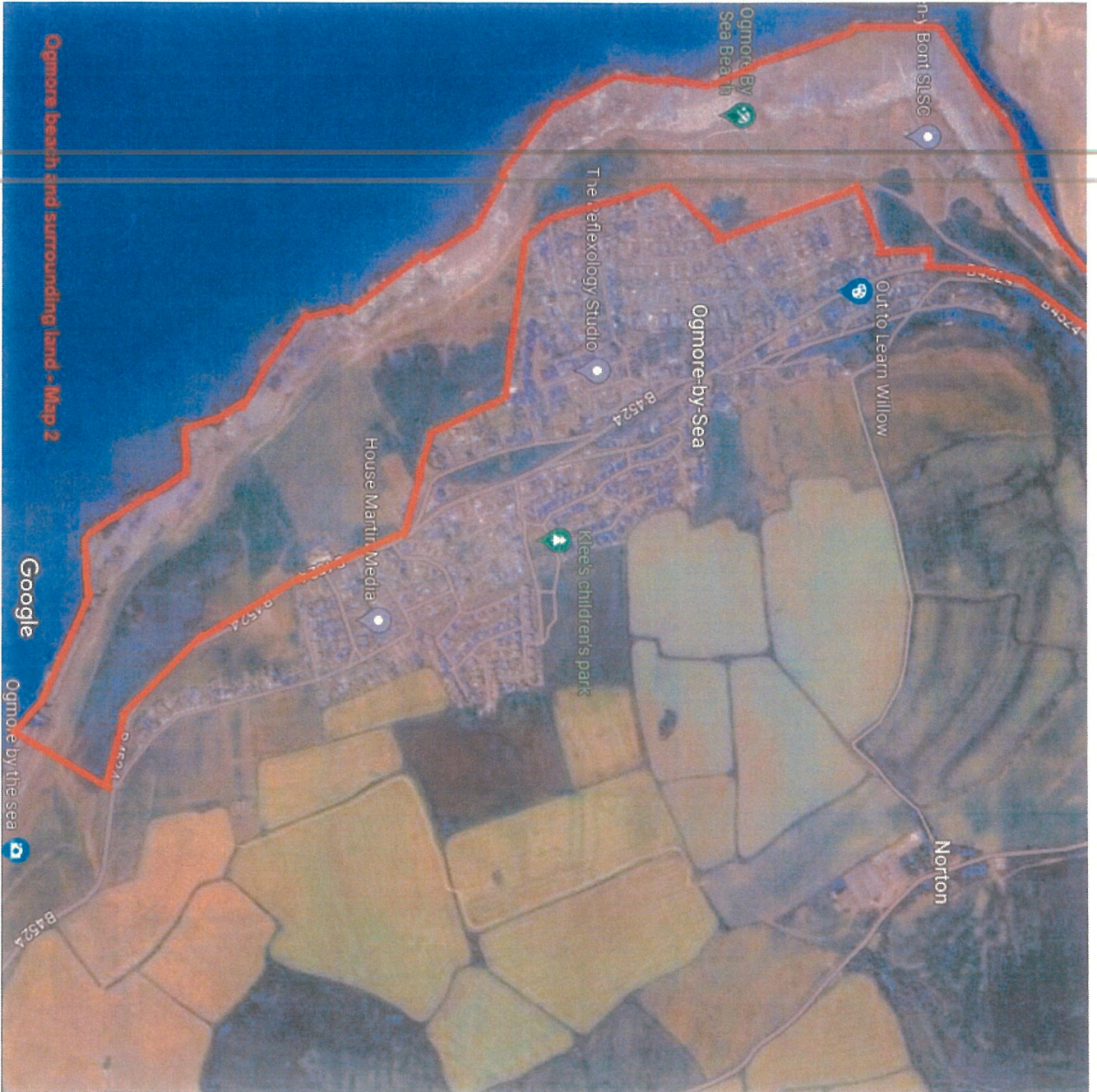

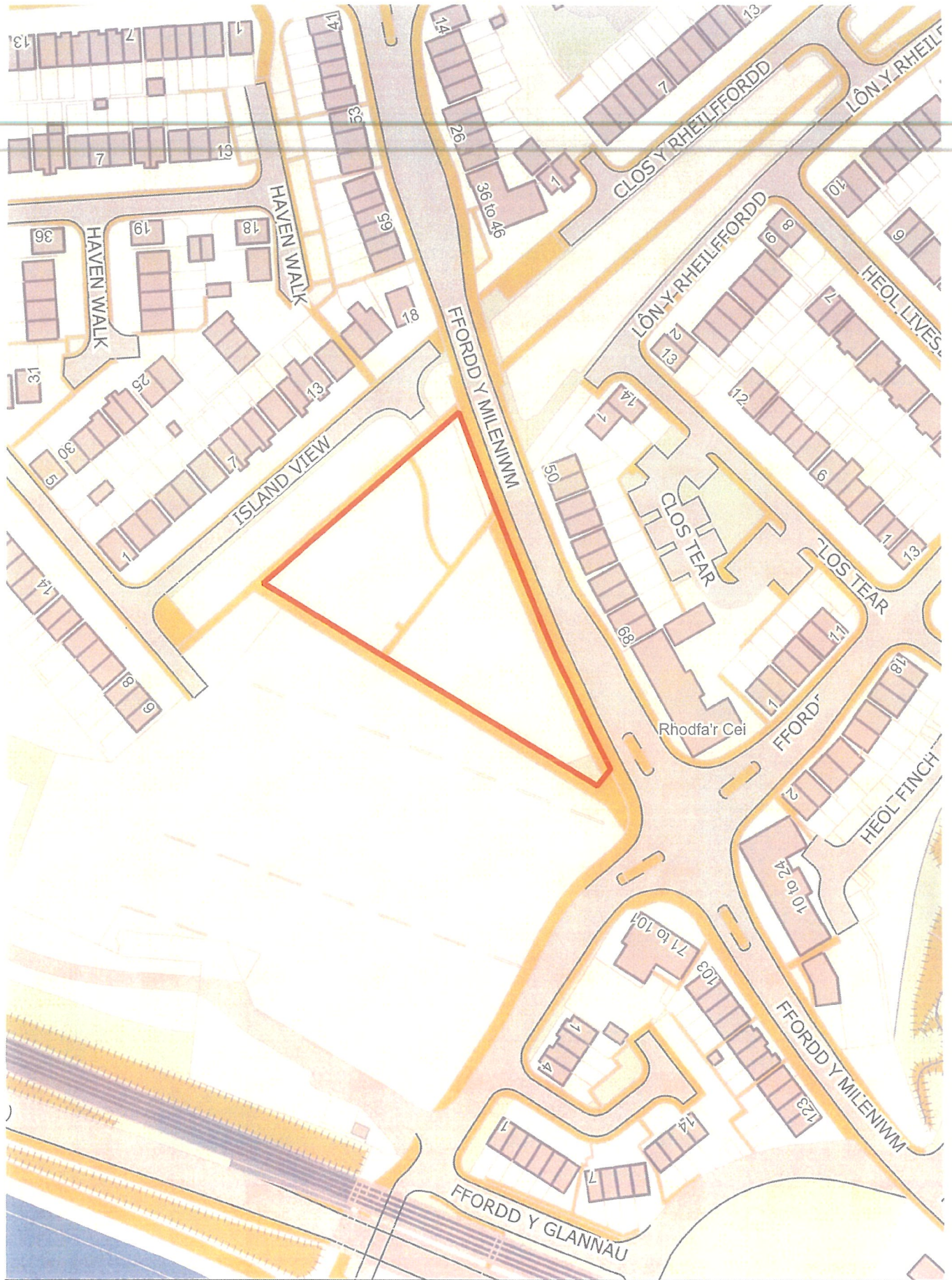
