Since the extension of opening hours, The St Fagans Castle does not only disturb residents by playing music exceptionally loudly, but has attracted a clientele that display anti social behaviour on a frequent basis. The police are regularly called to the premises to deal with incidents.

I have witnessed from my window bottles being thrown across the street, members of the public urinating into the road and vomiting on shop windows and have personally been disturbed by drunk people ringing my doorbell at 1.40am, who I believe would not still be out if the pub did not close at such a late hour.

It is unnecessary for a public house in Penarth town centre to be open until 2.00am on Friday and Saturday's, 2.30am on Bank Holiday Friday, Saturday and Sunday's and 4.00am on New Years Eve/Day, considering that Cardiff town is in such close proximity.

With regards to the above application.

As a resident of Penarth and living in fairly close proximity to the St Fagans Castle (commonly known as the "Fag") I strongly object to the application.

Even without further extension to the licensing hours the current situation around the immediate vicinity of this pub is appalling.

Walking within 50 metres of the place is already very intimidating, with the pubs' customers spilling out on the street.

There is loud music constantly blaring out, customers outside the pub swearing and shouting at each other. I have seen fights on the doorstep of the pub and have even witnessed a person leave the pub and then urinate in an adjacent shop doorway.

My granddaughter lives in Glebe Street with my daughter and her partner and they are literally afraid to walk past the Fag. There are a number of occasions where my daughter has been subject to lewd comments from customers of the Fag.

Extending the licensing hours will surely make this already disgraceful situation worse.

There can be no possible good reason to extend the licensing hours as this will clearly mean customers having the opportunity to consume even more alcohol and become even more intoxicated than they already are.

The only people to benefit from this application are the landlords who see an opportunity to sell even more alcohol whilst not taking their responsibilities as landlord seriously. This application does not benefit the local residents and the wider Penarth public in any way shape or form and I would hope that you reject this application without further consideration.
