Enabling Natural Resources and Wellbeing in Wales (ENRaW) Green Trails.

Local Access Forum Meeting – Dec 2021

#### 1. Project Background

- 1.1 The Green Trails project aims to pilot delivery of a coherent network of green corridors within the South Wales Central region for the purposes of improving bridleway access and habitat connectivity. The project also explores financial and practical measures to secure the long-term sustainability of that network.
- 1.2 The objectives of the project are:
  - 1. To provide safe access opportunities for horse and bike users
  - 2. To establish sustainable management systems that enhance ecological resilience
  - 3. To animate communities and establish connective structures at a regional level.
  - 4. To undertake feasibility for development of a gateway facility that will contribute to long term sustainability.
- 1.3 The proposed project activities follow production of a Green Trails Network Plan funded under an earlier round of ENRAW small scale funding.
- 1.4 The proposed project activities are:
  - Delivery of a long distance horse and mountain bike trail linking hubs of bridleway access across the South Wales Central region (Bridgend, Cardiff, Vale of Glamorgan, RCT, Merthyr) as developed in the Green Trails Network Plan (includes route, works and costs).
  - Enhancement of biodiversity in and around the trail. This includes mapping adjacent habitats and establishing connections to the core route; collection and assessment of baseline ecological data; Prescribing detailed management practices by location; and producing practical guidance for volunteer partners.
  - Animating and supporting local, user and nature conservation groups towards delivering and sustaining the trail.

- Scoping and feasibility for development of a profit making gateway facility (bike-park) that will contribute to financially sustaining the regional trail in the long term.
- 1.5 Delivery of the trail will involve creation of legal rights and ground works. It will be focussed around maintaining momentum amongst emergent user communities by involving them in the process and demonstrating achievements.
