

## Community Cohesion Policy: The Origins

Community cohesion has been influential in shaping government policy since the 2001 disturbances in Burnley, Oldham and Bradford.

Community cohesion was chiefly developed at a city-wide or area level to develop support a broader consensus in support of diversity.

# Background to community cohesion policy in the UK

"Community cohesion is what must happen in all communities to enable different groups of people to get on well together.

A key contributor to community cohesion is integration, which is what must happen to enable new residents and existing residents to adjust to one another."

# Background to community cohesion policy in the UK

The UK Government's vision of an integrated and cohesive community is based on three foundations:

- People from different backgrounds have similar life opportunities
- People knowing their rights and responsibilities
- · People trusting one another and trusting local institutions to act fairly


And three key ways of living together:

## Community Cohesion Policy in Wales

Getting on Together, the community cohesion strategy for Wales, was launched in December 2009.

It provides an understanding of community cohesion that is distinct and different to the agenda in England, in that it recognises the potential for deprivation and social exclusion to undermine community cohesion.

# Background to community cohesion in Wales

Local authorities recognised as the agency best placed to take the lead on promoting community cohesion at the local level.

Initially, local authorities received an annual grant from a fund to deliver projects to promote community cohesion.

Since 2014 Welsh Government has funded the 8 Community-Cohesion Co-Ordinators, who cover all 22 of the Welsh Local Authorities between them on a regional basis.

## **Community Cohesion Co-Ordinators**

Responsible for delivery of the Welsh Government's 'Community Cohesion Delivery Plan 2017-2020' across their cluster of local authorities.

# **Objective 1:** Work at a strategic level to break down barriers to inclusion and integration across marginalised groups

#### 1.1 Wellbeing of Future Generations Act

Regional Community Cohesion Coordinators (RCCCs) will act in a 'critical friend' role to support Local Authorities and PSBs to deliver against the Cohesive Communities and A More Equal Wales goals

#### 1.2 Strategic Equality Plans and Equality Impact Assessments

RCCCs will support Local Authorities to reflect and embed local and regional cohesion priorities in Strategic Equality Plans and Equality Impact Assessments.

# **Objective 1:** Work at a strategic level to break down barriers to inclusion and integration across marginalised groups

#### 1.3 Representation and policy input

CoCos will be a point of contact for the Equality and Inclusion organisations and help them understand and respond to local cohesion priorities and community tensions

#### 1.4 Communications

CoCos will seek to foster links between national, regional and local campaigns, particularly during campaign weeks, and will consider opportunities for other events to promote positive messages.

# **Objective 2:** Work at a local level to break down barriers to inclusion and integration for particular groups and communities

#### 2.1 Working with particular groups or communities

RCCCs will provide cohesion support for socially or economically marginalised groups or communities that are identified as priorities at a Local Authority or PSB level due to low, or risk of low inclusion or cohesion.

#### 2.2 Gypsy and Traveller communities

RCCCs will provide cohesion support around proposed and approved Gypsy and Traveller Accommodation

**Objective 2:** Work at a local level to break down barriers to inclusion and integration for particular groups and communities

## 2.3 Ensuring Welsh Government funded programmes help local cohesion priorities

RCCCs will be a point of contact for local programme managers to help them understand and respond to local cohesion priorities and community tensions, in order to maximise the impact in delivering against local and regional priorities.

# Objective 3: Supporting migrants, refugees and asylum seekers and host communities during the integration process

#### 3.1 Support for refugees and asylum seekers

RCCCs will support Local Authorities to mainstream activity in relation to Refugees and Asylum seekers in existing and new dispersal areas, the Syrian Resettlement programme, children's schemes and other schemes so that Local Authorities can meet emerging needs.

#### 3.2 Economic migrants

When identified as a local priority group under Objective 2, RCCCs will provide cohesion support to meet emerging needs of groups of economic migrants (such as European migrants, Roma), and of areas where large scale movements of people are taking place.

# Objective 3: Supporting migrants, refugees and asylum seekers and host communities during the integration process

#### 3.3 Host communities

RCCCs will monitor community tensions and support Local Authorities and PSBs to consider cohesion of host communities in their Well-being Plans.

When identified as a local priority under Obj 2, RCCCs will support LAs to work with settled communities who are expressing most concern or hostility towards migrants

## 3.4 Understanding migration trends

RCCCs will share local information on immigration trends and support Local Authorities to understand current and future population changes and plan their services accordingly.

## 4.1 Monitor and respond to community tensions and link to Community Safety work

Local Authorities will work in partnership with the Welsh Police Forces to contribute local intelligence to the community tensions reporting process, and provide cohesion support to inform mitigation and preventative activities issues at a local level.

## 4.2 Support schools to tackle hate-related bullying and to promote respect

RCCCs will help Local Authority education colleagues to monitor hate-related bullying respond to requests by schools for support in tackling hate-related bullying

## 4.3 Provide support to victims and ensure hate crimes and incidents are dealt with in a satisfactory manner

RCCCs will support Local Authorities to mainstream activity to tackle hate crime, including sharing data on trends and hot spots, supporting partnership working across Community Safety Partnerships, Public Service Boards, the Police, Local Health Boards, housing and social services, and helping to embed work to tackle hate crime into Well-being Plans and Strategic Equality Plans

## 4.4 Work to encourage victims of hate crime to report and seek support

RCCCs will support the National Hate Crime Report and Support Centre to build levels of reporting through helping to develop third party reporting centres, strengthening grassroots support

### 4.5 Safeguarding

RCCCs will work to establish links with Social Service Departments and Safeguarding Boards, seeking to establish co-ordinated safeguarding training and awareness-raising sessions on hate crime, made crime, modern slavery and tackling extremism.


## 4.6 Support public bodies and communities to tackle all types of modern day slavery

RCCCs will work with the six RASGs to facilitate training and work with The Welsh Government on awareness-raising campaigns, seminars and conferences.

## 4.7 Reduce the exposure of young and vulnerable people to extremist groups in order to minimise radicalisation

RCCCs will offer community cohesion advice and support to Local Authority Single Point of Contacts (SPOCs) and CONTEST boards to help manage delivery and work through Prevent and emergent legislation and policies.

RCCCs will support engagement with communities impacted through Prevent to understand community feeling and any potential community tensions



#### Vale of Glamorgan Community Cohesion Group

#### Purpose:

- To engage with the full diversity of the local community in order to build trust and confidence in the local authority and police
- To enable the sharing of information between communities and the public sector to promote reassurance, transparency and invite local scrutiny to practices

## Joint Cardiff & Vale of Glamorgan CONTEST Board

The CONTEST Board ensures representation across all areas of the CONTEST strategy and enables effective discussion and action across each of its work steams.

The Board has well-established information sharing protocols to allow the sensitive and confidential sharing of intelligence products between BCUs and other partners, particularly with regard to individuals/institutions vulnerable to radicalisation and to exchange information on risk levels, threats and mitigating actions.
