Executive Summary:

- The Homes and Safe Communities Scrutiny Committee identified, on the 14th October 2020, that housing and homelessness provision as part of the recovery from COVID-19 should be reviewed by the Committee and consideration be given to setting up a Task and Finish Work Group in order to achieve this.
- The report asks the Homes and Safe Communities Scrutiny Committee to confirm the membership of the proposed Task and Finish Group.
- The report asks the Homes and Safe Communities Scrutiny Committee to approve the proposed scope, meetings/sessions required and timescale for the review.
- The subsequent report(s) produced by the Task and Finish Work Group will be referred back to the Scrutiny Committee for consideration and any recommendations or comments approved be referred on to Cabinet.

Recommendations

- 1. That the Committee confirms the membership of the Task and Finish Group, to comprise of at least 6 Members (from Labour, Conservative, Plaid Cymru, Llantwit First Independent and Vale Independents political groups, as well as co-opted members on the Scrutiny Committee) and that the first meeting of the group be undertaken as soon as practicable following its establishment.
- **2.** That the proposed scope and timescale for the review be approved as attached at Appendix 1 to the report.
- **3.** That reports of the Task and Finish Group be referred to the Scrutiny Committee (Homes and Safe Communities) for consideration.

1. Background

- 1.1 All five of the Councils Scrutiny Committees in considering their work programmes for 2020/21 were requested to put forward items for consideration for review and the most appropriate forms of scrutiny for each of these, including "task and finish".
- 1.2 At its meeting on the 14th October 2020, the Scrutiny Committee, identified housing and homelessness provision as part of the Vale of Glamorgan Council's recovery from Covid-19 as an area that should be reviewed by the Committee and consideration be given to setting up a Task and Finish Work Group in order to achieve this. This recommendation is in line with the councils adopted Coronavirus Recovery Strategy (min C334 21st September 2020) where an action specifically was agreed to work with partners to sustain the reduction in homelessness achieved during the crisis.
- 1.3 In undertaking the review, it is envisioned that the following meetings/sessions will be arranged:
- 1.3.1.1 Looking at the legal and financial considerations and framework as well as the general background and scope to housing provision during Covid-19 and beyond with briefings from Housing, Legal and Finance Officers of the Council;

- 1.3.1.2 To review allocation priorities and the provision of help and support with briefings from the relevant Council Officers, partners and (external) expert witnesses (such as Citizens Advice and Pobl);
- 1.3.1.3 To review the governance arrangements around housing provision, with briefings from Council Officers and external partners from the multi-agency 'coordination cell' (such as Probation, Health and Social Services, Registered Social Landlords and Community Safety);
- 1.3.1.4 To review the current house building programme and homelessness policy and strategy; and
- 1.3.1.5 To look at 'best practice' from other similar local authorities as well as potential testimony from 'expert' witnesses within the Council or externally (such as Shelter Cymru and Citizens Advice Bureau);
- 1.3.1.6 Collation of findings and evidence, to agree recommendations and suitable conclusions by the Work Group to refer back to the Committee.

2. Key Issues for Consideration

2.1 Attached at Appendix 1 to this report is a proposed review scope outlining the objectives and desired outcomes for the review, the information that would be required, the methods to be employed in undertaking the review and details of the timescales, including start and finish dates.

3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?

- 3.1 Looking to the long term the review of housing and homelessness provision will offer recommendations and a strategy around the Council's approach to this provision in order to ensure that such services are sustainable and that future need and demand for services is understood.
- 3.2 Taking an integrated approach the review of housing and homelessness provision will include looking at the current multi-agency arrangements in place around housing as well as engagement with partners and other external parties in order to carry out this review and ensuring the review takes into account the wellbeing objectives and goals of the Council (such as 'An Inclusive and Safe Vale').
- 3.3 Involvement and Collaboration the review will involve potential contributions from a variety of external parties such as expert witnesses and other partners or third sector organisations.

3.4 Prevention - the review will help to address issues around housing provision that could occur and impact on the ability of the Council to house tenants as well as addressing reasons behind homelessness within the Vale of Glamorgan as we move on to a recovery phase.

4. Resources and Legal Considerations

Financial

- **4.1** There are no direct financial implications in respect of this report.
- 4.2 The establishment of a time limited Task and Finish Group is considered to make optimum use of limited resources. In view of the fact that no new group would commence work on a review prior to other work being finalised, it is recommended that the Task and Finish Group undertake its first meeting as soon as practicable following its establishment.
