Relevant paragraph(s) under which dispensation can be granted <i>(See (a) to (j) overleaf)</i>	a) Of the six Councillors, three have a potential financial interest and two have a non-financial prejudiciary interest. I may also have a non-financial prejudiciary interest if the proposed routes are amended to bring a road closer to Tredodridge. This means our Community Council is not quorate for the purposes for which the dispensation is sought.

<p>Details of the Prejudicial Interest</p>	<p>The Vale of Glamorgan Council are currently consulting on a new road between M4 J34 and the A48 at Sycamore Cross. One of the proposed routes would result in a road slightly closer to our home than the existing road and it will of course have increased traffic levels. If the route is amended in any way to bring it even closer to Tredodridge it would result in a significant increase in traffic noise and potential increased pollution levels affecting my home. This will give me a prejudiciary interest.</p>
<p>Details of any Position of responsibility / control held on your Council (e.g. Chairman / Vice-Chairman / Cabinet Member)</p>	<p>I am a Pendoylan Community Council Councillor</p>
<p>Reason(s) to support the application and why you consider the Standards Committee should grant a dispensation</p> <p><i>(Use a separate sheet of paper if necessary)</i></p>	<p>The Pendoylan Community Council consists of 6 Councillors, the majority of whom have an interest in the proposed road. Within the Community, I am aware there is mixed opinion although there are a large number of residents who expect the Community Council to act on their behalf.</p> <p>I believe that the WELTAG process including consultation needs to be conducted in a fair manner to ensure that those directly affected by the plans are able to engage and respond. The Community Council should be in a position to report the facts of the process and receive individual comments from those we represent. A dispensation to engage in conversations regarding the process, including any decisions on what the Community Council should be raising as potential unfairness to the Community, would allow me with fellow Councillors ensure we keep an impartial view with regard to options whilst ensuring the process remains fair to all in the Community.</p>
