Executive Summary:	

• To consider an application for dispensation from a Member of the Vale of Glamorgan Council and the use of the Monitoring Officer's delegated powers in consultation with the Chairman of the Standards Committee.

#### Recommendation

1. That the use of the Monitoring Officer's delegated powers in respect of the application for dispensation from Councillor Mrs. R. Nugent-Finn be noted and endorsed.

#### **Reasons for Recommendation**

**1.** Having regard to the use of the Monitoring Officer's delegated power in consultation with the Chairman of the Standards Committee.

#### 1. Background

**1.1** The Standards Committees Grant of Dispensations (Wales) Regulations 2001 permits Members to apply to Standards Committee to speak and, if appropriate, to vote on issues which due to prejudicial interests, they may not otherwise be able to speak or vote or remain in the room.

#### 2. Key Issues for Consideration

- 2.1 An application for dispensation was received from Councillor Mrs. R. Nugent-Finn on 18<sup>th</sup> February, 2020 to speak, vote and remain in meetings when issues are raised (including budgets) in respect of Sully Primary School due to the fact that her son attends the school.
- **2.2** At the last meeting of the Standards Committee on 23<sup>rd</sup> January, 2020 a number of applications of a similar nature was granted, with the Committee resolving that should any similar applications be received, the Monitoring Officer's delegated powers in consultation in consultation with the Chairman be used to determine such applications.
- **2.3** For the Committee's information the Monitoring Officer, following consultation with the Chairman, confirmed her approval of the application for dispensation on 26<sup>th</sup> February, 2020. The application, having been granted until the next Local Government Elections in accordance with paragraphs (d), (e), (f) and (i) of the Standards Committees Grant of Dispensation (Wales) Regulations 2001.
- **2.4** Committee is therefore requested to note and endorse the use of the Monitoring Officer's delegated powers in consultation with the Chairman.

The Standards Committees (Grant of Dispensations) (Wales) Regulations 2001 specifies that the Council's Standards Committee may grant dispensations under Section 81(4) of the Local Government Act 2000 where:

- (a) no fewer than half of the Members of the Council or of a committee of the Council (as the case may be) by which the business is to be considered has an interest which relates to that business;
- (b) no fewer than half of the Members of the Executive of the Council (i.e. Leader and Cabinet) by which the business is to be considered has an interest which relates to that business and either paragraph (d) or (e) also applies;
- (c) Members' inability to participate would upset the political balance of the Council, or any of its committees by which the business is to be considered, to such an extent that the outcome would be likely to be affected;
- (d) the nature of the Member's interest is such that the Member's participation in the business to which the interest relates would not damage public confidence in the conduct of the Council's business;
- (e) the interest is common to the Member and a significant proportion of the general public;
- (f) the participation of the Member in the business to which the interest relates is justified by the Member's particular role or expertise;
- (g) the registerable interest relates to business, which is to be considered by an Overview and Scrutiny Committee of the Council, and the Member's interest is not a pecuniary/financial interest;
- (h) the business relates to the finances or property of a voluntary organisation of whose management committee or board the Member is a member otherwise than as a representative of the Council and the Member has no other interest in that business, provided that any dispensation shall not extend to participation in any vote with respect to that business;
- (i) it appears to the Standards Committee to be in the interests of the inhabitants of the area of the Council that the disability should be removed; or
- (j) it appears to the Standards Committee to be otherwise appropriate to grant a dispensation. [If this circumstance is relied upon it will be required to be reviewed on a 12 month basis Local Government (Standards Committees, Investigations, Dispensations and Referral) (Wales) (Amendment) Regulations 2016 (3(1)A)]
