## 322 APOLOGIES FOR ABSENCE -

These were received from L. Tinsley (Vice-Chairman) and G. Watkins (Independent Members) and Councillors R.M. Birch, B.T. Gray and A.R. Robertson (Vale of Glamorgan Council).

# 323 MINUTES -

328 PUBLIC SERVICES OMBUDSMAN FOR WALES ANNUAL REPORT AND ACCOUNTS 2020/21 (MO/HLDS) -

The purpose of the report was to present to Members extracts from the Annual Report and Accounts for the Public Services Ombudsman for Wales for the year ending 31st March 2021 in respect of Members' Code of Conduct matters.

The report referred to three main roles of the Ombudsman, which were to consider complaints about public service providers in Wales, to consider complaints of members of Local Authorities who had breached their Authority's Members' Code of Conduct and to drive systematic improvement of public services.

Mr Alexander drew the Committee's attention to page 33 of the report and expressed his concern over the reference that *"many members of Town and Community Councils often do not take up training opportunities offered on the Code of Conduct. Whilst there is no statutory obligation for members to complete such training, we and the Monitoring Officers across Wales strongly advise them to do so."* In addition, the Monitoring Officer advised that an invitation was extended to the proper officer of each Town & Community Council to attend statutory training as part of the Council's Member Induction & Development Programme following the last Local Government Election in 2017 and that the opportunity was already scheduled to be repeated following the upcoming 2022 election.

In response, Mrs Hallett raised a suggestion that Committee Members also be invited to join training sessions attended by Vale of Glamorgan and Town & Community Council Members. The Committee supported Mrs Hallett's suggestion alongside Mr Alexander's supplementary suggestion that Committee Members also receive training regarding Equality, Diversity and Inclusion as related to the reference on page 35 of the report for the need to promote equality and respect. **RESOLVED** –

(1) T H A T the Public Services Ombudsman for Wales Annual Report and Accounts 2020/21 as appended to the report be noted.

(2) T H A T Independent Standards Committee Members be invited to attend training provided to both Vale of Glamorgan Council elected members and Town and Community Councils, as part of the Vale of Glamorgan Council's Member Induction and Development Programme following the May 2022 Local Government Elections, on the following topics:

- Code of Conduct, and
- Equality, Diversity and Inclusion.
