Executive Summary:

1. To apprise Members of the position with regard to arrangements for the Standards Conference.

1. Background

- 1.1 A Standards Conference is usually held on an annual basis. The Conference is aimed at Councillors, Officers and Independent Members involved in promoting and maintaining high standards of conduct within authorities in Wales and provides an opportunity to network and discuss issues of common interest and best practice.
- 1.1 Invitations are usually extended each year for up to four delegates from the Ethics and Standards Committee of each Local Authority in Wales, the Fire Authorities in Wales and the Welsh National Parks to attend.

2. Key Issues for Consideration

- 2.1 Following communication that the Standards Conference was due to be held on 9th February, 2022 all Members of the Standards Committee were circulated with the information attached as Appendix 1 to this report.
- 2.2 Due to the fact that the Conference is being held virtually there is to be no limit on attendance and Members of the Standards Committee have been requested to advice the Principal Democratic and Scrutiny Services Officer as to whether they will be able to attend in order for the necessary email contact details to be forwarded to the organiser so that the invitations to the virtual Conference can be sent directly.
- **2.3** For Committee's information, the Monitoring Officer of the Vale of Glamorgan Council will also be attending the Conference.
