### Executive Summary:

#### Recommendation

#### **Reason for Recommendation**

**2.** To comply with the regulations and obligations for the grant of dispensations to speak and vote.

#### 1. Background

- 1.1 The Standards Committee Grant of Dispensations (Wales) Regulations 2001 permits Members to apply to Standards Committee to speak and, if appropriate, to vote on issues which due to prejudicial interests, they may not otherwise be able to speak or vote or remain in the room.
- 1.2 In order to deal with the applications as quickly as possible, it is necessary for the Standards Committee to receive full information of the interests involved and why in the Member's opinion dispensation should be given.
- **1.3** Applicants are advised that they are also able to attend the Standards Committee meeting to present their application if they wish to do so.
- **1.4** All Vale of Glamorgan Councillors and Town and Community Councils have been advised that previous applications that had been agreed during the last term of office ceased at the time of the Local Government elections held on 5<sup>th</sup> May 2022.
