Purpose of Report:	To consider applications for financial assistance funded from the Welsh Church Act Estate.

#### **Executive Summary:**

- A budget of £60k has been set for issuing grants during 2024/25.
- The total general unrestricted reserve standing at £167k as at 31st March 2024.
- It is proposed £20k of this sum is utilised in 2024/25 for the provision of grants and therefore the total grants budget for 2024/25 is now set at £80k.
- One grant claim awarded in 2023/2024 for £10k has been withdrawn and replaced with a grant claim for a new project to be considered at this meeting. Further details are summarised later in this report.
- Following the withdrawal of the £10k the total grants budget available in 2024/25 becomes £90k.
- On a trial basis the maximum grant that can be potentially awarded has been increased from £5k to £10k.
- Grants totalling £18.880k were awarded in Tranche 1 at the meeting dated 31<sup>st</sup> July 2024 amended appendix attached at Appendix A1.
- Grants totalling £34k set out in Appendix A2 are recommended as part of this report.
- A remaining sum of £37.120k is available for allocation during 2024/25.

#### Recommendations

**1.** That Committee considers and approves the applications for grant assistance as set out in Appendix A of this report.

#### **Reasons for Recommendations**

1. In furtherance of the objectives of the Trust.

#### 1. Background

- 1.1 The Welsh Church Act Estate Committee has delegated authority to manage the trust's affairs in accordance with "The Scheme" the Welsh Church Act Estate as vested in the Council.
- 1.2 The purposes for which the Welsh Church Act fund may make grants is set out in summary at Appendix B to this report.
- **1.3** The applications received are set out in Appendix A to this report.

#### 2. Key Issues for Consideration

- **2.1** Appendix A to this report sets out a summary of the applications to be considered.
- 2.2 The revenue outturn for 2023/24 and projections for 2024/25 make provision for grant allocations of £90,000 in 2024/25. This includes a sum of £20,000 which has been carried forward from the grant allocation for 2023/24 and £10,000 from a grant awarded in February 2024 which has been withdrawn.
- 2.3 Tranche 1 of 2024/25 grant awards were approved by Committee in July 2024 as set out in the table below, the appendix A included in the report has an incorrect sum for the grants awarded and a correct Appendix A1 is included as part of this report.

- 2.5 The Parish Church of Nicholas were awarded £10k at the Committee meeting of the 27<sup>th of</sup> February 2024. The purpose of the grant was to repair the lychgate. Between the time of the application and the grant award the lychgate was dismantled by order of the Diocese on the grounds of health & safety. Therefore, the grant for the original project has been withdrawn and replaced with a new project for consideration at this meeting.
- 2.6 This leaves a sum of £37,120 to be allocated as part of a third tranche in January 2025.

## 3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?

3.1 The Trusts actions need to comply with Charity Law and its decisions are independent of the Councils obligations under the Well-Being of Future Generations Act.

#### 4. Climate Change and Nature Implications

**4.1** Welsh Church Act Investments are invested on an ethical basis and include sustainable investment funds and investments in renewable property collectives.

#### 5. Resources and Legal Considerations Financial

5.1 The sum of £60k has been provided for grants in the Trust's revenue estimates for 2024/25. A further amount of £25k was transferred into reserves as at 31st

March 2024. Of this amount, £2.255k relates to the sale of a property which will be transferred to the restricted fund with the remaining sum being added to the unrestricted fund. It is proposed that £20k of this sum is made available for grants in 2024/25 together with a further £10k for a withdrawn claim originally awarded at the February 2024 meeting.

- 5.2 It is recommended that an allocation of £34k is made for applications for grant assistance as set out at Appendix A to this report, which will leave a remaining balance of £37.120 to be allocated during 2024/25.
- 5.3 The Welsh Church Act Fund retains an unrestricted fund to finance unforeseen costs associated with the maintenance of its investment properties at 31<sup>st</sup> August 2024 this fund stood at £167K at 31<sup>st</sup> March 2024

# VALE OF GLAMORGAN COUNCIL WELSH CHURCH ACT FUND

#### WELSH CHURCH ACT ESTATE COMMITTEE

### The Charitable purposes for which the fund may be applied.

The Welsh Church Act Estate Committee has delegated authority to manage in accordance with "The Scheme" the Welsh Church Act Estate as vested in the Council.

Set out below is a **summary only** of the purposes for which the Fund may be applied:

- (i) **Educational** Provision of benefits not readily available from other sources, and recreation, social and physical training facilities, at educational establishments, not normally provided by the LEA.
- (ii) **Relief in sickness** Assistance to persons who are sick, convalescent, disabled, handicapped or infirm, where such assistance is not readily available from other sources.
- (iii) Relief in need Assistance generally or to individuals in need, hardship or distress.
- (iv) **Libraries, museums, art galleries etc.** Advancing the appreciation of Welsh arts and literature in general.
- (v) Social and recreational facilities in general.
- (vi) **Protection of historic buildings etc.** Promotion of interest in Welsh architecture, history and science in general, for the benefit of Welsh people.
- (vii) **Medical and social research, treatment in general etc.** Preservation and protection of the physical and mental health of society in general. Provision of nurseries, convalescent homes and hostels
- (viii) **Probation etc.** Assistance to persons on probation or the families thereof.
- (ix) **Blind persons** Provision of welfare including accommodation.
- (x) **Aged persons** Provision of accommodation.
- (xi) Places of worship and burial grounds Restoration and maintenance.
- (xii) **Emergencies or disasters** Directly assisting persons in need.
- (xiii) **Other charitable purposes** Contributions to charitable organisations not inconsistent with the purposes of the trust.

The above is a précis only of the wide ranging purposes to which the Welsh Church Act Fund may be applied, and in cases of doubt reference should be made to the actual provisions of the scheme document.
